In this case, the author can describe the relationship between the article and the articles or other works that have been published, conduct a brief review of the articles or works, and show the originality of the author's article. Second, the authors describe important aspects related to the problem being studied. In this case, the author can also mention the reasons and purposes for discussing the problem in the article in question. This section is intended to show the scholarly contribution of the author in the articles he writes the issues raised by the author are very important for publication.

Please make the page setting of your word processor to A4 format with the margins: bottom 3 cm and top 3 cm, left 3 cm, and right 2.5 cm. For the body of the paper, please use Garamond 12, single spacing. Should always be written in the font Garamond 12, especially in the figures and tables. The length of the article in the introduction is 1000-1500 words, including all figures and tables.
