Please ensure that the information you fill in and the relevant documents you submit are true and reliable and that there are no false declarations. If any false information is found, CRN will permanently disqualify the applicant from applying for CRN scholarship and reserve the right to pursue legal responsibility.

Your answers may be in both English and Chinese.

Name: We fully respect the fact that you may not wish to use your legal name. Therefore, you may use your real name or nickname here. If you win, we will reconfirm with you the information you wish to be disclosed in the promotional materials.

Email: In order to prevent delivery failure, we recommend that you submit your application using Protonmail, Gmail, Yahoo, Hotmail.

WeChat ID: This is an optional field.

School & Major/Grade: Please enter the school, major and grade you are attending for the 2023-2024 school year. Please also indicate if you are exchanging schools or attending more than one school for that academic year. If you are not enrolled at the time of your application, please enter here the school and program you will be attending at the beginning of the next school year.

Grade Point Average: Depending on your school's criteria for calculating grades, it is recommended that applicants use either a "percentage" or "GPA" system. The default grade point average is 100 (on a 100-point scale) or 4.0 (on a GPA scale). If your school has a different GPA calculation, please contact us.

Grade Rank: This field is optional. The format is "Grade Rank / Total Number of Students in Grade". For example, "3/97" means that your grade point average is the 3rd highest out of 97 students in the year. This is because some schools have generally low grade point averages (for example, even the top major may have a GPA of 3.5). Therefore, we encourage applications to fill in the grade ranking in order to present a more complete and accurate picture of your grades.

In principle, CRN scholarships require applicants to have a GPA of 3.0 or higher, or a grade point average of 80 or higher, or to be ranked in the top 30% of their grade. However, if you have faced any special difficulties that have affected your grades, please describe them in question 4 ("What special difficulties did you face growing up?"). ) and we will take your special circumstances into account and relax the criteria. If you make it to the final review, we will require you to submit school transcripts.

Address-related information: Please include the location of your primary school for the 2023-2024 school year.

Question 1, Identity: Reflections on your identity and community: We believe that as a member of a sexual minority group, you must have a unique story of your own. We want to hear your story. Your reflections on your identity and on your community.

Question 2, Pride: Choose three things that you feel best represent you and that make you proud! This is not limited to the traditional "accomplishments". We look forward to getting a full picture of your efforts. Anything you've been working on that you're proud of is fine. Please be concise and direct and be aware of word limits.

Question 3, Growth: Every difficulty you have experienced represents your growth. We would like you to tell us what you have learned from your setbacks and challenges, how you have grown, and what you have thought about it to help us understand you more fully.

Question 4, Goals: Please think about the goals you hope to achieve in the coming year, including academic, work and personal growth. Think about how the CRN scholarship can help you. It can be more than just financial help, but it can be purely moral motivation or anything else.

Question 5, Other: Select questions to answer, leaving blank will not have a negative impact. Everyone has a lot of stories that can't be categorized, so if you have a story that hasn't been told yet and also want the judges to get to know you more fully, use the space in this question to add to it. Please note that it must be something related to the CRN Rainbow Scholarship.

## **Privacy Statement**

We are fully committed to protecting your personal data and information. It is of paramount importance to CRN that your privacy is protected when processing data and we will continue to do so throughout our business processes. What personal data do we collect about you?

- The personally identifiable information provided, such as your name, address, phone number, microphone number, school information, and any other personal information relating to you.

What personal information about you can we disclose?

If you make it to the final selection stage, we will show your story to qualified judges during the public judging stage. The display will remove your name, contact information, school information, etc., but will keep your city and use pseudonyms for the names of relevant people and organizations, as appropriate. We will not disclose applicants' personal information in any way or form unless required or permitted by law.

How is your personally identifiable information used?

We use your contact information to get in touch with you, for the purpose of informing you of the outcome of your application, and for resources that may be of interest to you and to provide you with possible assistance. We use your personally identifiable information for scholarship-related data analysis and to monitor changes, trends and characteristics of applications.

How is your personal information protected?

We take electronic procedural safeguards to protect your personal information. Your application data is stored in our internal secure protected area, which prevents unauthorized users from accessing the personal data you provide during the security period. Only staff members of the CRN scholarship team have access to your personal information in order to provide you with relevant product information or services, and CRN trains all scholarship staff on the importance of protecting our applicants' information and maintaining the confidentiality and security of your personally identifiable information.
