After you finish reading each piece, write a short, one or two sentence summary of the piece that explains the author's main point and at least two of the supports, or evidence, that the author includes to back up his/her argument. After you summarize, write at least one inquiry based (level two or three) question that deals with the ideas and arguments raised by each participant in the discussion forum. Please use language and grammar properly and maintain an academic tone in your written work.
