

Holy Light Bible App Privacy Policy

Thank you for using our Holy Light Bible App ("we", "us", or "our"). We are committed to protecting your privacy and ensuring a safe and secure user experience. This Privacy Policy explains how we collect, use, and protect your information when you use our app, especially the permissions related to your device's camera, calendar, download, and share features.

By using this app, you agree to the collection and use of information in accordance with this policy. If you do not agree to this policy, please do not use the app.

1. Information We Collect

We may request certain permissions from your device to enhance your experience using our app. The information we collect depends on your use of the app and the permissions you grant.

1.1 Camera Permissions

In order to provide better services and user experience, this app may request access to your device camera permissions. We will use your camera permissions strictly in accordance with the following principles:

Camera permissions are only used to take photos or videos to support related features (such as uploading avatars, shooting instant content). We will not store, share, or publicly disclose any content obtained through the camera without your explicit consent. You can manage or revoke camera permissions at any time through device settings, which will not affect the use of other services except camera-related functions. We promise that your privacy and security are our top priority. If you have any questions, please feel free to contact us.

1.2 Album permissions

This app may request access to your device album permissions to achieve the following functions and improve service quality:

Album permissions are only used to select, upload or save pictures and video content. We will never read, store or share your album content without authorization, and all operations require your explicit consent. You can manage or revoke album permissions at any time through device settings, which will not affect the use of other services except album-related functions.

1.3 Download permissions

The app may request access to your device's storage space to download:

Bible images.

We do not access or collect data stored on your device that is not related to the app's functions. All downloaded materials remain on your device and are not shared with our servers unless you choose to share them.

1.4 Sharing permissions

The app may request permission to share content with others through social media, email or other platforms. You can choose to share:

Bible verses.

Quotes, images, or scriptures you create or save.

We only share content that you actively choose to share, and we do not share any personal information or data without your consent.

2. How We Use Your Information

We may use the information we collect to:

Provide and improve the functionality of the app.

Send notifications or reminders for daily readings, events, or Bible-related activities (if enabled).

Facilitate sharing of Bible content through social media or other platforms.

Ensure the proper functioning of the app and troubleshoot technical issues.

We do not sell, rent, or share your personal information with third parties for marketing purposes. However, we may share anonymous data or aggregated information for analytical purposes.

3. Data Security

We take the security of your data very seriously and take reasonable steps to protect it. However, please be aware that no method of data transmission or storage is 100% secure and we cannot guarantee the absolute security of your data.

4. Your Rights and Choices

You have control over the permissions you grant to the app. You can manage or revoke access to your camera, calendar, and storage at any time through your device settings. If you do not grant specific permissions, some features of the app may not work.

You can also manage notifications and other preferences in the App's settings.

5. Third-Party Services

The App may contain links to third-party services, such as social media platforms or external websites. These third-party services have their own privacy policies, and we are not responsible for their content or privacy practices.

6. Children's Privacy

Our App is not intended for use by children under the age of 13. We do not knowingly collect personal information from children. If we become aware that we have collected personal information from a child under the age of 13, we will take steps to delete such information.
