We've moved to exclusive online gaming due to COVID pandemic. As of the time I write this report, that will continue through at least mid-June.

### **ADC Social Media:**

Project Social Media Advertising: Ongoing project to get members to actively engage Social Media accounts and show that we are an active and engaged game. aDC will post Events to the Facebook (and future Meetup.com) page. For each game engaged with a comment, for each website, aDC will recommend 5G. For example, prior to 1st game of the month, John Doe RSVP's "No" for the game but posts a comment about missing out or after game posts something like "I heard game was awesome! Sorry I missed it," that would be worth 5G. Or perhaps John Doe RSVP'd "Yes" and after game posted, "Thanks for the game everyone. I'll never forget Jane Smith's xyz scene!" would equally be worth 5G. If/once we have a
