

**PARENT-PROVIDED
TRANSPORTATION AGREEMENT**

WHEREAS:

- (a) The Parent requires transportation service for his or her child(ren) residing within the boundaries of Wolf Creek School Division and has agreed to provide transportation services to school/ from school or to and from school for the child(ren);
- (b) Wolf Creek School Division has agreed to compensate the Parent for the provision of transportation services for the child(ren) to and from school;

NOW THEREFORE, the parties to this Agreement agree as follows:

- 1.0 This Agreement shall commence upon the Effective Date and shall be terminated pursuant to the provisions contained in this Agreement.
- 2.0 The Parent shall provide transportation and a suitable driver being _____ [insert name of driver or drivers] for the child(ren) listed below to and from their place of residence, as indicated, to the school indicated or to the school bus route.

- 3.0 The personal information collected pursuant to this Agreement is collected under the authority of the *School Act* that mandates program operations and services offered by the Wolf Creek School Division and will be protected under the privacy provisions of the *Access to Information Act* and the *Protection of Privacy Act*.
- 4.0 The Parent recognizes that it is the Parent's responsibility to ensure that the child(ren) embarks onto the correct parent-determined transportation vehicle designated by the

Parent (the "Transportation Vehicle"), and then correctly disembarks at the location referred to above. The Parent recognizes that it is the Parent's responsibility and the responsibility of the driver of the Transportation Vehicle (if it is not the Parent) to ensure that embarking and disembarking from the vehicle at the school is done in a safe manner. The Parent also recognizes and fully understands the potential hazards in allowing his/her child(ren) to take the Transportation Vehicle including all risks and hazards related to injury during the embarking and disembarking at the school where she/he meets the Private Vehicle, and also include all risks and hazards associated with being transported by the Transportation Vehicle. The Parent particularly recognizes that it is the Parent's responsibility to ensure that the Transportation Vehicle is properly operated, properly insured and safe for the Parent's child(ren).

- 5.0 The Parent hereby waives Wolf Creek, its elected officials and officers, agents, administrators, independent contractors, employees and volunteers from and against all claims, demands, losses, costs (on a solicitor and client full indemnity basis), damages, actions and causes of action of any nature whatsoever, including any claim of negligence, arising out of or in relation to any injury or bodily injury including death resulting therefrom, sustained by the Parent, the Parent's child(ren) during any time the said child (children) is embarking onto, disembarking from, and travelling in the Transportation Vehicle.
- 6.0 The Parent agrees that he/she is entirely responsible for the replacement, maintenance, repair and/or operating expenses for the Transportation vehicle used to transport the child(ren) to and from school.
- 7.0 The Parent shall notify Wolf Creek of any change of residence location within five (5) days of such change of residence location.
- 8.0 Wolf Creek shall pay a transportation allowance to the Parent for each day that the child(ren) referred to in two (2) preceding is/are transported to the location in the Transportation Vehicle indicated as determined by PowerSchool attendance records.
- 9.0 The transportation allowance referred to in seven (7) above will be an allowance at the current rate approved by Wolf Creek, which is \$_____/day for total distance travelled from home to bus/school for each day in attendance at school.
- 10.0 This Agreement may be terminated by either party giving notice in writing to the other party, and upon notice being given, this Agreement shall terminate on the last day of the same month in which the notice is given.
- 11.0 The Parent is advised to inform the company that insures the Transportation Vehicle that the Parent is transporting the child(ren) listed on this agreement to and from school.
