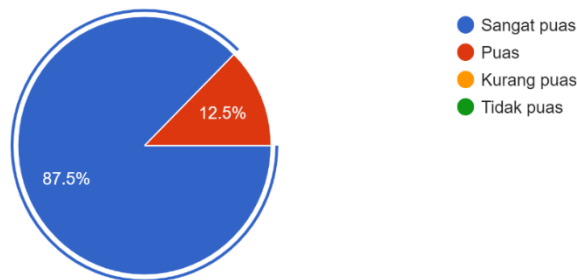


Figure 3. Participant satisfaction
