

Theft is a common law offence, which means that it comes under the jurisdiction of the Land.

This is the jurisdiction that covers interactions between living men and women.

In the jurisdiction of the Land, things cannot be owned or possessed by anything but living men and women.

This makes sense, as no creature or lifeless object can communicate their possession of anything to us.

Also in the Bible, which is where our laws effectively come from, God gave man dominion over the Earth.

The Theft Act of 1968 starts with this:

Basic definition of theft

“A person is guilty of theft if he dishonestly appropriates property belonging to another with the intention of permanently depriving the other of it; and “thief” and “steal” shall be construed accordingly.”

Remember a man or a woman is not a ‘person’, which is a non-physical corporate body in the jurisdiction of the Sea and not a man or a woman..

See the definition of dishonestly from section 2

2

“Dishonestly”

A person’s appropriation of property belonging to another is not to be regarded as dishonest—

if he appropriates the property in the belief that he has in law the right to deprive the other of it, on behalf of himself or of a third person;

Does it seem likely that legislation would be written with such a glaring loophole if it were not so?

Those who write legislation know full well about the limits of their authority, but write their rules in an attempt to deceive us into thinking that there is no limit to what they can order.

Because people have had the jurisdictions hidden from them, they have not been able to use this apparent loophole prior to this time.

So it is not theft if we remove things, which we have previously thought to 'belong' to companies, without paying.

Basically it means that everything is up for grabs, for free, if it is 'owned' by a limited company, but not if it is in the property of a living man or woman.

This ties in with the fact that in 1302 the Pope claimed everything for the return of the messiah and placed it in the Unam Sanctam Trust.

All companies are trusts (as they must be if the Pope put everything in the Trust), however, this action was contrary to the word of God in the Bible, which means it is null and void.

This gives support to my assertion that all utility payments, taxes, mortgage and other loan payments are voluntary. See documents below

If a company cannot own anything, you have never had to pay any charges.

Legislation would not be constructed the way it is, if it were not attempting to use sharp practice to deceive us.

Should you not feel comfortable taking something that is 'lying on the land' simply use a credit card and then ignore the bill. See Post and Mail document below.

To prevent a free for all and individuals suffering, small businesses should unincorporate forthwith.

There is no need to declare this as if you run a business you are only voluntarily subject to legislation from the jurisdiction of the Sea.

Simply stop paying all taxes, and stop taxing any employees.

Remember the company assets do not belong to anyone.

If the company premises is not privately owned then no-one has the right to those either.

It would be good for those that wish to continue to trade to sort out an equal share of business profits, that is up to them

Should companies not unincorporate, then anyone (including the former employees) has the right to remove their goods, for as I explained earlier, a company cannot own anything.

Larger multinationals that have boards of directors are likely to suffer most.

I would suggest that the employees band together as unincorporated companies and carry on, if the business is ethically sound and does no harm and causes no loss.

Those that run businesses that do cause harm are subject to common law and can be tried

by a jury.

All those engaged in the running of the business, will be jointly and severally liable for any harm or loss.

This will encourage those involved in such activities to clean up their act or leave the business.

Research apparently suggests that the best number for a jury is 7

There are many more implications to this, but I thought I'd let everyone know the basics.
