Acceptable Use Policy Amendment

Artificial intelligence models can enhance classroom learning, the implementation must be guided with proper training and ethical considerations. At Visitation, we embrace the use of AI and other emerging technologies with responsible oversight, transparency, and appropriate use.

Al technology is to be utilized ethically, appropriately, and responsibly in the classroom as stated in class syllabus and as stated in this policy. It is the student's responsibility to only use Al technology tools for school assignments and work that generate text or creative works when approved and/or guided by their classroom teacher. Additionally, Al technology may only be used for specific assignments and/or projects that have been specifically approved by the teacher or as stated in the syllabus. Any unauthorized use of Al models outside of teacher approval will be considered plagiarism and handled as stated in the school division handbook.

The guidelines for students on the appropriate use of AI tools to prevent academic dishonesty as stated below.

Guidelines for the use of AI tools:

- Submission of work that uses or is aided by unauthorized or uncited technology as one's own work, is considered a violation of academic integrity.
- Students are expected to develop their own understanding and knowledge of the subject
 matter and demonstrate their mastery in their own voice. The use of aforementioned tools as
 a learning aid should be used for reference purposes only and not to be used as a substitute
 for original ideas and/or thinking.
- As with any other use of sources, students should cite their work if they have used these tools in any way that might inform their work.
 - Included but not limited to generating outlines, examples, used as a portion or total of submitted work.
 - If possible, students should use an annotated bibliography that describes in detail how they used an Al tool.
- Students should always verify the information gathered from AI tools for validity and accuracy, just as one would with Wikipedia or any other informational resource. AI technology tools and large language model tools such as ChatGPT, DALL-E are exactly those- tools. They should be used intentionally and thoughtfully.

This includes not adding any personal and identifiable information to AI technologies.
 This includes name, birthdate, address, financial information and other information that can be used to identify a person and location.
