

1. Singapore International Graduate Award (SINGA)

- You should have excellent written & spoken communication skills

2. ADB-Japan Scholarship Program

The ADB-JSP scholarship might be perfect for you if you want to level up your education in Asia. **It's been around since 1988**, helping out students from countries borrowing money from the Asian Development Bank.

If you want a master's degree in economics, science, business, management, or technology, this scholarship program could be a game-changer. The government **gives out around 300 scholarships** yearly, but there's a catch: **you can only use it at universities that are part of the program.**


