Birds are to be penned by 10am. Viewing is from 10am to 11am. Sale is from 11am to 12.00pm.

Conditions & Terms of Sale

1. A CASH only fee of five dollars on all pens is payable to the Tumut District Poultry Club Inc on 9th August 2026. Items of equipment will also attract a fee of five dollars per item. All electrical items for sale are to be tested and tagged.
2. A maximum of three birds per pen.
3. The reserve price is per pen and not per bird.
4. The person/s selling the poultry &/or items of goods (the "Vendor") has the authority to enter into these conditions & terms with the TDPCI.
5. The Vendor declares that they are the genuine owner of the poultry and/or goods item listed for sale.
6. The Vendor declares that the poultry &/or items of goods listed for sale are free of any encumbrances, liens or charges whatsoever and are not subject to lease, higher purchase or finance agreements. The Vendor is selling their own personal assets and is free to do so.
7. Any person/s seeking to purchase poultry &/or items of goods (the "Purchaser") is required to complete a registration form supplied by the TDPCI, prior to making an offer of purchase ("Bid"). A Purchaser's fee of two dollars is payable at the time of registration. The Purchaser accepts these Conditions & Terms.
8. Subject to the reserve price, the highest bidder will be the buyer of the pen and/or item of goods.
9. The Purchaser shall pay the winning bid price in cash directly to the Vendor at the close of business. Ownership of the poultry &/or items of goods will not transfer until the purchase price has been paid in full.
10. No pen shall be removed from the Poultry Pavilion without the consent of the TDPCI Stewards/Representatives.
11. No poultry are to be delivered or removed in bags or tied with rope.
12. **Unhealthy or vermin infected birds shall be removed.**
13. In the event of any dispute, the TDPCI President will be the sole arbitrator and the decision is final.

14. I/We absolves and indemnifies the TDPCI, and the Tumut Show Society, from any blame or liability whatsoever for any loss, damage or injury that may occur.
15. I have read and agree to the Conditions & Terms of Sale & authorise my consent when I complete this booking sheet.
