It would specifically belong to Shinji Minato (Boy C), known as being a resident of the house where Junko Furuta's kidnapping, torture and murder was carried out. Naturally, I am aware of the seriousness of the accusations, which is why I will now review everything we know for sure about Shinji Minato, and then present the evidence that we have been gathering during this last time.

The murder of Junko Furuta was one of the most terrible crimes committed in Japan due to its brutality and the very young age of the criminals who committed it. The house where these crimes

occurred belonged to the parents of Shinji Minato, who was 15 to 16 years old at the time of the crime. He received from the Tokyo District Court about 4 to 6 years in prison. However, his story continued on August 20, 2018, after stabbing a person in the neck when he had a discussion with him in the parking lot. At just before 5:30 p.m., Shinji Minato, of no known occupation, allegedly beat the victim, 32, in the right shoulder with a metal baton on a road in the Higashiochino area. The suspect also slashed the victim's throat with a knife.

SAITAMA (TR) – Upon the [arrest last year of Shinji Minato](#), 46, on suspicion of attempted murder, news outlets provided very little coverage of the story. The few articles that did appear provided little information about the suspect, merely saying that he is unemployed.

Here we discover that the trial carried out against Shinji Minato was full of irregularities and that it presented very little coverage by the Japanese media. The defendant during the trial began to speak inconsistently and unclearly, citing the article:

*"Much of the remainder of the hearing was filled with the incoherent ramblings of Minato, according to Friday, with the defendant claiming that the stabbing was a "fabrication"."*

Shortly after this article, no more was learned about Shinji Minato or the outcome of his trial, so there was no way of knowing what was of the trial or its results for long.

## SHINJI MINATO'S REPEAT OFFENCE

It is December again.

Ever since I had learned about the murder of Junko Furuta, I cannot help but thinking of her towards the end of each year. It is particularly so this year, as it marks the 30th anniversary of her horrendous tragedy. This month 30 years ago she was gradually tortured to death, while general members of the public were happily busy in excitement for the approaching

Now back to the case, she begins to cover much of what Shinji Minato's life was like after the death of Junko Furuta and how is his relationship with his current neighbors. Among the most important data we have:

- He tried to become a muay thai fighter, but when he was booed by the public that they were able to recognize him, he decided to resign.
- He and his family moved several times in different cities after his liberation: the city of Ichikawa (Chiba Prefecture), Kyoto, Osaka and the city of Aizu (Fukushima Prefecture) before his address was unknown.
- Between 2006 and 2010 he married a foreign woman, after which he had a daughter.
- At the time in which the A JAPANESE IN GLOUCESTERSHIRE's article was published (late 2018) Shinji Minato's father had died two years ago (late 2016 or early 2017).
- He moved to the apartment where he committed his second crime recently (in June 2018). He did it alone, since by that time he had separated from his wife and had kept the custody of his daughter.

As you can imagine, Shinji Minato's neighbors had no idea who he was. However, that did not prevent them from raising a certain fear between them. Here I will leave some testimonies left by them:

*"The apartment had a new manager. The monthly rent used to be about 65,000yen with only half of the apartments occupied. The new manager reduced the rent down to 39,000yen; that's when shady characters came to live there. I thought he was a Tekiya because he hang stall screens to dry, you know, those screens that go round food stalls. He did not seem to go out to work at all though. When he came out of his room, he would descend the stairs shouting. appeared vigilant. I was afraid that he might do something one day..... I wonder whether he would come back."*

*"He wasn't tall - only just above 160cm or so - but was muscular. His head was totally shaven and he always wore bulky T-shirts and shorts. He would suddenly speak to you about President Trump or something like that, but I avoided to interact with him as I didn't know what he was up to without even working. When a neighbor was once searching for something in his car, standing outside with the door open, he (Minato) tried to shut the door hard. Was he trying to hurt him? That neighbor was the man who lives right under him. They seemed to be having a row in the morning of the incident."*

*"Oh Yes. I've caused me trouble by shouting and stomping on the floor in the middle of the night. When I went to talk to him, there was no answer to my knocks. When I caught and spoke to him outside, he either diverted the topic or asked me whether I was hearing noise at night. I thought he was crazy, but somehow the noise stopped to my relief. Then the stabbing happened --- I was astounded. To think that I could have been stabbed --- I am very scared."*

For many years, this was the last flow of information we had from Shinji Minato. And the worst part was that it looked like he had gotten away with it.

However, everything changed in mid-2020, when a member of our team came up with the name of an account after looking around in Japanese-speaking sites: denngekiraketto

It was not a great clue, but it was worth checking out, however, the more it was investigated in that account, the more suspicious it became. The first thing one notices on this Twitter account is the unusual number of tweets dedicated to Shinji Minato, he is not dedicated to writing about the other murderers or those responsible for the crime, he is only dedicated to writing exclusively about Shinji Minato and nobody else. Here I will leave some photos of said tweets (a quick review of many of his current tweets can demonstrate this point):



These tweets were suspiciously aligned with much of the data we know so far from Shinji Minato. As we saw earlier, he was charging that the evidence that he had stabbed someone in the neck was

"fabrication" against him. In addition to that during the trial he spoke and behaved inconsistently. Now in these tweets we can see how denngekiraketto expresses that Shinji Minato has been living a "serious life", fighting against the United Nations and the technological crimes it commits, and that he has a "great feeling of justice and duty towards humanity" . However, an important fact mentioned here is that denngekiraketto considers the evidence against Shinji Minato to be the work of a group, the same type of argument that Shinji gave during his trial. In addition, it is also clear that denngekiraketto is a believer in Qanon, this is a vitally important fact since some of Shinji Minato neighbors had mentioned that he was spending a lot of time talking about Donald Trump:

*"He would suddenly speak to you about President Trump or something like that, but I avoided to interact with him as I didn't know what he was up to without even working"*

Now for those unfamiliar with Qanon, this is a very popular conspiracy theory among Donald Trump fans. Not to mention also that this Twitter account is also a Trump fan:



After this evidence, we concluded that at this point it was worth getting to review each and every one of the tweets that this account had published just to be sure. It was thanks to this that we found 2 very important data. This Tweet was written in early 2020, which would indicate that denngekiraketto's father died in early 2017 or late 2016, the same estimated date as the death of Shinji Minato's father.

The second major clue we got came from reviewing his posts, specifically their dates:

The account, until before August 19, 2018 was quite normal. There was nothing remarkable about it. However, August 20 of that same year was a very special day, because as you will remember it was the date that Shinji Minato was arrested for stabbing someone in the neck.

Picture 14: [Judgment] Imprisonment for one year in June, 250 days of detained days were included in the sentence, and the sentence was suspended for three years (probation) + litigation costs accused by the defendant.

He received a sentence of only 250 days, plus 3 years of probation and having to pay the court costs of the accused. After almost three decades of having tortured, raped and murdered Junko Furuta, after demonstrating to the Japanese justice system that in the end he learned nothing of his crimes, and after almost killing another person, he only received 250 days in prison.

By this point, we were almost certain to have found one of Junko Furuta's killers. However, due to the importance of our accusations, it was our obligation to exhaust every possible doubt of the equation. We were to hear evidence of HIMSELF. That is why for almost a month we deployed a series of different false accounts occupying different roles, so that we could earn his trust with one of us... and in the end we did it.

Under a false narrative, we managed to convince Shinji Minato to speak to us on July 1, 2020, we will first leave a record of the interview as it was written:




The interesting thing about this image is that he shows what could well be the icon of his YouTube channel. This had a character 'で' as the beginning of its name, in addition to being orange. With this track in hand, we started looking for potential channels on YouTube matching this description. To begin, we look for the meaning of denngekiraketto in Japanese, which translates as でんげきらけっと (Electricity). The character で was repeated again, so it was expected that its channel should mean electricity in Japanese. Now, at last we could find his channel on YouTube, using the first characters 'で ん' we searched among the different accounts looking for the one that matched all the descriptions. This YouTube channel is called でんげき, which can be translated as Electricity. But it was not the only evidence, it was also that the channel is dedicated to talking about electronics (a fairly common topic in denngekiraketto's tweets), and as if that weren't enough this channel was subscribed to a boxing channel and another dedicated to QArmyJapan (Both would be topics of interest to Shinji

Minato, after leaving prison he wanted to be a professional wrestler and QAnon's theories have been of interest to him at least since 2018):

With this at least it is safe to say that the denngkiraketto's and でんげき accounts would be related.

So to end this extensive post, I would like to declare that within this research group we share the same pain and grief that many of you surely feel for this particular case. Junko Furuta was a girl who fought until the last minute for her right to live and be happy, and to see that in the end she had

to die while murderers like Shinji Minato are still alive is undoubtedly a greater form of injustice within modern history. Almost 30 years have passed since that crime, and Shinji Minato still remains a public threat to his neighbors and everyone around him. Here we firmly believe that the decision of the magazine Shukan Bunshun (週刊文春) to publish the names of the criminals, knowing that they would receive light penalties for their crime was the correct one. And it is for this action that we firmly maintain that our duty, knowing the information we handle, is to publish this information equally so that it reaches the largest number of people possible on the internet.

We would like to thank all those who were able to make the existence of this post possible: To all the members of our team who spent so many weeks researching the Shinji Minato account for this research, to JAPANESE IN GLOUCESTERSHIRE for allowing the Junko Furuta's case could reach foreign countries, Tokyo Reporter for being one of the few sites on the internet to have covered the recent crime of Shinji Minato, all the people around the world who have been interested in the case and who to this day and await justice for the victim, and especially, we would like to thank Junko Furuta herself, her courage and effort in life was what inspired us to carry out this investigation to the end. This report is both ours and hers and we sincerely hope that it can bring her justice in the end.
