Abstract

The abstract in the English language should be written only in one paragraph, 10 pt, and Calisto MT font. The abstract contains a clear elaboration of research purpose, method, result, and conclusion. The number of words in the abstract is between 150 - 250 words. Reference should not be written in the abstract, but if it is indispensable, the authors; name and publication year should be cited. The nonstandard abbreviation should be avoided, but if it is essential, the full name should be specified in its initial mention.

Keyword: consist of 3-5 words or phrases.

INTRODUCTION

The introduction should include the background, urgency of the research, and gap analysis with existing research so as to show the novelty provided. The purpose of the research should be clear in the introduction, exclude tables and figures, and be straightforward. The attitude of the research should be included, whether correcting, debating, or supporting previous research.

References should be up to date within the last 10 years and refer to primary literature. The problems, objectives, and uses of the research are written narratively in paragraphs, with no need for special subheadings.

The introduction is written in Calisto MT-11 upright, with 1 space. Each paragraph begins with a word that protrudes 5 digits, or about 1 cm from the left edge of each column.

METHODE

Contains the type of research, time and place of research, targets, research subjects, procedures, instruments and data analysis techniques as well as other matters related to the research method. Methods used should be accompanied by references; relevant modifications should be described. Data analysis procedures and techniques should be emphasised in the literature review article. The research stages and analyses

should be described in detail. The introduction is written in Calisto MT-11 upright, with 1 space.

RESULT AND DISCUSSION

The results and discussion are written in one unit; the author is not allowed to present the previous results and discussion in the form of a new chapter. The method of writing the results and discussion is done directly by reviewing one by one the research results obtained with relevant

references and prioritising primary sources. Research results can be supplemented with tables, figures, and graphs to clarify the verbal presentation of research results.

Results and discussion should be presented in the same section, clearly and briefly. The discussion section should contain the benefits of the research results, not a repetition of the results section. The results and discussion sections can be written in the same section to avoid too long citations. Tables or graphs should show different results. The results of data analysis must be reliable in answering the research problem. References in the discussion should not repeat references in the introduction. Comparisons with the findings of previous studies should be included.

Tables are inserted in the centre or at the end of each text describing the research results/objectives. If the width of the table is not enough to be written in half a page, it can be written on a full page. The title of the Table is written from the left centre aligned, all words are capitalised, except conjunctions. If more than one line is written in single space. For example, see Table 1.

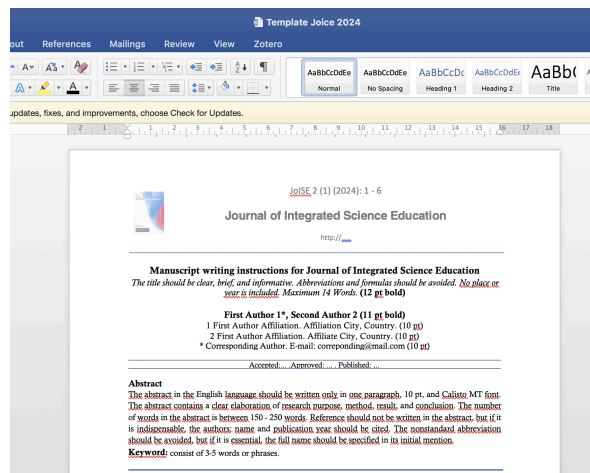


Figure 1. Template JoISE

Results in the form of images, or data made into images/schemes/graphics/diagrams/etc., the presentation also follows the existing rules; the title or name of the image is placed below the image, from the left, and spaced 1 space from the image. If there is more than one line, there is a single space between the lines. For example, see Figure 1.

The discussion focuses on how the data and results of the analysis relate to the research problem or objectives and the broader theoretical context. It can also be an answer to the question of why the facts as found in the data. The discussion is written attached to the data discussed. The discussion should not be separated from the data discussed.

CONCLUSION

This section contains research results, research findings in the form of answers to research questions or the essence of the results of the discussion. Conclusions from the research results are presented briefly, narratively, and conceptually. The impact of the research must be stated. This section is presented in paragraph form, not in the form of numbering/listing. Can also present recommendations for next steps.

REFERENCES

Reference in the article should cite the last name and year. If citing from some authors, it should be ordered based on the most recent reference. If citing from the article written by two authors, then all authors' names should be cited. Meanwhile, if citing from the article written by three or more authors, then it is cited by writing the first author's name followed by et al. Citation should be written in reference part. Every cited reference should be written completely in the reference part. An unpublished reference is not suggested to be cited in the article. References should be written according to the APA style. To maintain consistency in the way of referencing, citing and bibliography, you should use a Reference Manager application, such as Zotero, Mendeley, or other paid applications. Written in single space, there is a space of 1 space between the bibliography.
