## <u>Update on merger staff collective</u>

- Trying to unite the board meetings
- MPNAI has been struggling for a long time demonstrates their need
- Each neighborhood needs to vote separately do we need to make both neighborhood needs
- MPNAI is the weak link
- The neighborhoods are so close more presence within the city
  - History of the neighborhoods

- Legalities of it have to ask hard questions
- Need documentation in place to move forward
  - Must get in compliance with our own minutes and ourselves
- Fiscally responsible, administratively responsible
- Moving through this quicker will get us in compliance quicker
- Midtown is a different conversation than Phillips West
- Phillips West
  - Shared events, shared programming, and staff collaborative
- Community meeting for open discussion
  - Drafting new bylaws in late October or early November
  - 2-part community board meeting
- The bylaws between East and Midtown largely match and reflect one another
- Advisory seats, specific board member seats (Little Earth, x number of seats for midtown, x number of seats in east Phillips)
- David send powerpoint to board
- Concern: how are resources being shared? Supposed to be a good relative, how
  do we take the service work and not lose sight of what we are doing it for
- The lines have been arbitrarily drawn do we want to rethink this
- Can staff pick the community meeting times?
  - One meeting avenues for residents to talk to staff
  - Set dates at our next meeting
  - Send out examples of future board with the type of representation and advisory member – vision of what this would look like
- October 10th Community Meeting joint community meeting on merger 7PM on Zoom – put in the Alley
- Voting is open for a week November 7th-14th
  - Staff could post open office times
- Include Karen Clark in outreach
