Central Office Update

- Bill Binder has recently joined our office as our new HR Specialist:
 - Bill Binder is our new Human Resources Project Management Specialist. He has years of experience in administrative positions ranging from HR to Quality Assurance to Operations Management. Bill comes to our team from Dartmouth College where he worked in the Cancer Center as a Coordinator of several post-graduate programs.
- Terry Green will soon be joining us as our new Business Manager:
 - As our new Business Manager, Terry Green joins our team with thirty years' experience in Accounting & Business Administration. She has a strong and proven background in AP/AR, payroll and tax collection and preparation. Terry also has successfully obtained grants for Information Technology and has a sense for reducing costs. Most recently, Terry has been the Assistant Town Clerk for the Town of Rowe, MA.
- Contracts have been written and are in the process of being signed by board chairs.

Professional Development Provided to Our Teachers & Staff

- On Wednesday 4/12 during Trailblazer Hour, school-based teams used a common SU-wide agenda prepared by Pam Bernardo to apply the requirements of Act 173 for EST/MTSS/SPED Processes in examining their school's practices/system.
- On Wednesday 4/26, all WSWSU teachers and available staff met from 1:15 2:15pm for the third in a series of Trailblazer Hour sessions regarding Act 173 and EST/MTSS/SPED Processes. Led by Pam Bernardo (MTSS/EST Coordinator) and Troy, our third session engaged teachers in thinking through the process of identifying and documenting student struggles and needs through the EST and MTSS processes.
- On Wed. 5/3 during Trailblazer Hour, Pam Bernardo led all WSWSU teachers and available staff in a session on Inclusive Tier 1 (universal) Instruction using Differentiation.

Innovation Update

- All schools have begun VTCAP state testing, which will continue through the first week of June (with different grades/tests staggered through the window, and make ups).
 - Many technical issues have needed to be addressed at the state/platform level with the AoE and Cognia, including error messages interrupting or preventing testing despite our devices meeting all required specifications.
 - While awaiting technical support from AoE and Cognia, school and district coordinators have found workarounds by swapping devices and other means to ensure all students can access their state tests

- WSWSU schools will administer new state summative assessments after April break through June 7 (extended) in ELA (grades 3-9), Math (grades 3-9) and Science (grades 5, 8, and 11).
- Teachers have been trained as test proctors, and have given students opportunities to use the Practice Test at the VTCAP/Cognia website before taking the state summative tests to allow them to get used to the computer based test (CBT).
- In a 5/4 memo to superintendents from Heather A. Bouchey, Interim Secretary of Education (VT AoE), Bouchey states:
 - On technical challenges: "many of the challenges experienced are due to the delays in the IT contracting process, which gave us a shorter runway for rolling out and testing the new system than originally contemplated. As with any new system, we will continue to identify bugs as we go along. Your willingness to test and provide quick feedback when problems arise has mitigated many issues... We deeply appreciate your hard work, patience, and collaboration. Your thoughts, ideas, and feedback are very valuable, and your engagement with us has greatly helped address issues"
 - On test validity: "we are hearing some concerns about potential impacts of the rollout on the validity of test results, or even concerns about the new assessment more generally. These assessments are closely aligned with Vermont standards and meet or exceed all psychometric standards for state summative assessments. We have read communications that purport otherwise, in particular about the Grade 9 English Language Arts (ELA) and Mathematics assessments. I can state unequivocally that these claims are false. Further, we have seen nothing to undermine our confidence in the assessment results, but we are carefully monitoring results to ensure there are no systemic, statewide, or even regional patterns that indicate bias or inaccuracy of the assessment results... I recognize that opinions about summative standardized assessments differ, and it might be tempting to raise questions about assessment in light of the current technical challenges. We need to remember however, that these assessments do have a place in, and are a federally required aspect of, Vermont's system for understanding student progress."
 - On results: "We will, as we do every year, monitor the data closely to ensure that
 results are valid and reliable. We will also provide template communication
 materials for districts and schools to use in advance of assessment results going
 public"
