## Shoot Indoors Denver Membership Agreement



You are agreeing to the following terms and cancellation policy.

This agreement is made between Shoot Indoors Denver and "Member"/"Members"

- 1. ALL NOTICES TO SHOOT INDOORS DENVER SHALL BE MADE VIA E-MAIL TO "MEMBERSHIP-DENVER@GOSHOOTINDOORS.COM, OR MAILED USPS (CERTIFIED OR REGISTERED, RETURN RECEIPT REQUESTED) TO: SHOOT INDOORS DENVER, 410 RARITAN WAY, DENVER, CO 80204. In this agreement Shoot Indoors Denver is an indoor shooting range that grants special privilege to Members who opt-in to this membership program. "Member" in this agreement seeks to take advantage of the membership program and agrees to the below terms and conditions.
- Membership loyalty program services are pre-paid and dues must be current for "Member" to take advantage of benefits. A lapse in payment exempts Shoot Indoors Denver from executing their obligations of the membership program.
- 3. If any part of the Agreement is held by a court of competent jurisdiction to be void or unenforceable, the remainder of the terms and provisions of the Agreement shall remain in full force and effect and shall not be affected.
- 4. BUYER'S DEFAULT: Members shall be deemed in default of this Agreement upon the failure to comply with and of the terms and conditions of the Agreement, including, but not limited to, the obligation to make any payment as and when due. Upon default, Shoot Indoors Denver shall have all rights and remedies available, including termination of the Agreement and institution of an action for all applicable damages. If Shoot Indoors Denver delays or refrains from exercising any rights under this Agreement, Shoot Indoors Denver does not waive the right to receive full and timely payments and other charges due under the Agreement.
- 5. Shoot Indoors Denver, or similar will appear on your credit card and/or bank statements when payments are processed for your membership.
- 6. In the event of an ACH transaction being returned due to insufficient funds, a fee of \$20 will be assessed to the account holder. The membership account will then be suspended from active use until rectified; members will be unable to access any membership benefits, including range access. During this suspension, membership fees will continue to accrue, and the member remains responsible for all ongoing charges.
- 7. **CANCELLABILITY and TRANSFERABILITY:** This membership is NOT negotiable, transferable, or cancellable except as otherwise provided herein.

## **CANCELLATION OPTIONS, NOTICE PERIODS, & FEES**

Members have the right to terminate this agreement under the following circumstances:

- 1. There is a **90 day minimum term** of purchased membership or a cancellation fee of the **balance of the term along with a \$50 cancellation fee** will apply. Downgrades are not permissible within this term. Upgrades are always permitted.
- 2. Once the 90 day term is up, members may cancel or downgrade membership at any time. Any paid dues are forfeit immediately and no partial refunds will be given.
- 3. Cancellation will **NOT** be accepted over the phone.
- 4. The buyer dies or becomes disabled immediate termination is accepted.
- 5. The shooting range is moved to a location that is more than 15 miles from the location of the establishment when the buyer entered into the membership contract immediate termination is accepted.
- 6. This agreement can be canceled within three (3) business days of acceptance with forfeit of any initiation fees paid; membership fees paid will be refunded within this period unless the buyer made use of the range facilities or benefits during this time otherwise cancellation fees will apply.
- 7. NOTICE of intent to end membership MUST be delivered via email to **membership-denver@goshootindoors.com** Subject: Membership Cancellation Request for Shoot Indoors Denver. - 8. Shoot Indoors Denver reserves the right to cancel this membership agreement at its discretion at any time for any reason deemed appropriate.
