



Terms and Conditions for The Day's Student Survey Incentive

January 2026

1. Eligibility

This incentive is open to all schools who are active members of The Day and have secondary and college-age students who use The Day. It is open to global member schools, subject to applicable laws and regulations in their respective jurisdictions.

2. How to Enter

To enter, 20 students minimum must complete the survey and reference your school. By submitting an entry, you are agreeing to be bound by these Terms and Conditions.

3. Entry Requirements

Each submission requires a valid email address associated with your The Day membership. The school champion's email will be used to notify you if you are selected as a winner. To be considered, 20 student survey submissions must be fully completed, citing your school. Incomplete submissions will not be eligible. No purchase is necessary to enter this promotion. Participation is completely free. Teachers from the same school can enter; the prize will be awarded to the school, via the champion.

4. Promotion Period

The promotion period is valid from 12th January 2026 to Tuesday 3rd February 2026. All entries must be received by the specified deadline to be eligible. The specific entry deadline will be communicated on the registration form.

5. Winner Selection and Notification

20 student responses per school minimum are required to count as one entry for a school. Three entries will be selected at random to win a £50 Amazon voucher and will be selected and notified on Wednesday 4th February 2026. The winners will be notified via the email address associated with their school champion. The selected winners will have until 11th February 2026 to confirm their acceptance of the prize. If the prize is not claimed within this period, it will be forfeited and may be offered to an alternative winner.

6. Privacy and Data Protection

We are not collecting any student data, except for during the final question where students can opt in to hear from us about our new Student Advisory Group. Students' emails will only be used to send them information about the Young People's Advisory Group. It will not be shared with anyone else, and they can ask to be removed from the list at any time.
