These SMS Terms & Conditions govern your participation in the text messaging program offered by **CASA/GAL of Miami County**. By opting in to receive text messages from us, you agree to these SMS Terms & **Conditions**.

1. Program Description

CASA/GAL of Miami County may send SMS or MMS text messages to end users who have opted in to receive communications from us.

Messages may include, but are not limited to:

- Appointment, follow up, status, inquiry, or check-in messages;
- Other communications related to our services.

Message content may vary depending on your relationship with **CASA/GAL of Miami County**.

2. Consent to Receive Text Messages

By providing your mobile phone number and opting in to receive text messages, you authorize **CASA/GAL of Miami County** to send SMS and MMS messages to the mobile number provided.

You confirm that you are the account holder or authorized user of the mobile number you provided.

3. Message Frequency

Message frequency may vary.

You may receive recurring messages depending on your interactions with us, scheduled appointments, or needs.

4. Message and Data Rates

Message and data rates may apply.

Your mobile carrier may charge you for sending or receiving SMS or MMS messages.

CASA/GAL of Miami County is not responsible for any charges imposed by your mobile carrier.

If you provide a phone number that is not yours or that you are not authorized to use, you agree to indemnify **CASA/GAL of Miami County** for any claims, losses, or damages resulting from that action.

9. Privacy

You may terminate your participation at any time by replying **STOP**.

The SMS program is provided on an “as-is” and “as-available” basis.

CASA/GAL of Miami County does not guarantee that SMS messages will be delivered, received, or error-free. Delivery may be affected by your mobile carrier, network availability, device settings, or other factors outside our control.

13. Limitation of Liability

To the maximum extent permitted by law, **CASA/GAL of Miami County** is not liable for any indirect, incidental, consequential, special, or punitive damages arising from or related to your use of, or inability to use, the SMS program.
