Terms of Service

This Statement of Rights and Responsibilities ("Statement," "Terms") derives from 31 Games Principles, and is our terms of service that governs our relationship with users and others who interact with 31 Games, as well as 31 Games brands, products and services, which we call the “31 Games Services” or “Services”.

By using or accessing the Services, you agree to this Statement, as updated from time to time. Additionally, you will find resources at the end of this document that help you understand how 31 Games works. Because 31 Games provides a wide range of Services, we may ask you to review and accept supplemental terms.

To the extent those supplemental terms conflict with this Terms, the supplemental terms associated with the app, product, or service govern with respect to your use of such app, product or service to the extent of the conflict.

These Terms of Service (“Terms”) are a legal agreement between 31 Games and you. By using or accessing any 31 Games game or application (“Service”) you agree to be bound by these Terms.

By accessing or using the Service, you agree that you have read, understood, and accept to be bound by the Terms. 31 Games reserves

the right, in its sole discretion, modify or revise these Terms at any time, and you agree to be bound by such modifications or revisions.

Users are responsible for periodically viewing the Terms. Your continued use of the Service after a change or update has been made will constitute your acceptance to the revised Terms.
