

## WAIVER AND RELEASE OF LIABILITY FOR

## COMMUNICABLE DISEASES INCLUDING COVID-19

Please read this document carefully. By signing this document you will be waiving certain legal rights.

In consideration of being allowed to participate on behalf of **REJOICE CHRISTIAN SCHOOL**, **Inc.** Athletic Program and related events and activities, the undersigned acknowledges, appreciates, and agrees that:

- 1. My participation in this activity is purely voluntary and I elect to participate in spite of the risks. Participation includes possible exposure to and illness from infectious diseases including but not limited to MRSA, influenza, and COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness and death does exist; and,
- 2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS AND DANGERS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,
- 3. I willingly agree to comply with the stated and customary terms and conditions for participation in regards to protection against infectious diseases. If, however, I observe any unusual or significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
- 4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, WAIVE, FOREVER DISCHARGE, INDEMNIFY, AND HOLD HARMLESS Rejoice Christian School, Inc. and their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), from and against any and all lawsuits, claims, demands, causes of action, losses, damages, and liabilities (including attorney's fees and costs), on account of any injury, illness, disability, death, or loss or damage to person or property arising out of or in any way related to participation in this activity, including, to the fullest extent allowed by law, any such injury, illness, death, property damage or other loss which results from or is caused by THE NEGLIGENCE OF RELEASEES.

- 5. Should Rejoice Christian School, Inc. be required to incur attorney's fees and costs to enforce this agreement, I agree to reimburse it for such fees and costs.
- 6. I agree that the purpose of this agreement is that it shall be an enforceable release of liability and indemnity as broad and inclusive as is permitted by Oklahoma law. I agree that if any portion or provision of this agreement is found to be invalid or unenforceable, then the remainder will continue in full force and effect. I also agree that any invalid provision will be modified or partially enforced to the maximum extent permitted by law to carry out the purpose of the agreement.
- I HAVE CAREFULLY READ THIS WAIVER AND RELEASE OF LIABILITY, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IF FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
