#### 1. John Kaye (JISC) – update on IRUS

John Kaye gave an update on COUNTER services JUSP and IRUS. There has been a review of these services in the last 18 months. It became clear during interviews that the two needed to be rebuilt, as the back-ends aren't coping with the amount of data coming in. JISC will need to invest in these services if they are to continue.

Member interviews were undertaken – JUSP was critical and informed subscriptions choices and publisher discussions. IRUS – appreciated, but a nice to have rather than imperative.

A landscape review highlighted a viable alternative to IRUS. OpenAire Usage Statistics to be used instead. The review advised that IRUS is retired and OpenAire to be used instead.

OpenAire is COUNTER compliant, with full suite of R5 reports, but doesn't currently have API, widgets, and data is 1:1 between OpenAire and institutions.

JISC are considering requesting a national aggregation for usage from OpenAire. Also under discussion is the potential to migrate R5 data from IRUS, influencing the OpenAire roadmap.

A formal announcement will be sent out late July/early August, with guidance and webinar in August and September. IRUS will look to be retired at the end of the year (31 Dec 2025)

It was noted by committee members that work has already been ongoing with OpenAire to get more registrations at UK institutions. Support from OpenAire has not always been good and they have been slow to answer queries.

Better support will be needed by OpenAire for this, in comparison to the levels of support that have been given by JISC. It was suggested that a longer time will be needed for institutions to move over to OpenAire, plus the timing with REF makes things more difficult.

There is an OpenAire onboarding process, which JISC would like to test with some volunteers. Those who wish to volunteer should contact John Kaye directly at [john.kaye@jisc.ac.uk](mailto:john.kaye@jisc.ac.uk)

There was a soft launch last week for the COAR IRD, which provides an alternative to openDOAR. They are looking for a 'responsible organisation' to maintain the UK part of this - there were enquiries as to whether UK-CORR would be appropriate. It was agreed that it would be a good thing to be involved in. It was suggested that Paul Walk be brought in to provide updates and further information.

**Action:** Agustina to liaise with Paul and see when he would be available to talk to the committee.

## **4. Update on the UKRI 'Improving the open access research information landscape' work**

Agustina shared a [report](#) recently from UKRI. A webinar from UKRI will be given in due course (UKRI have moved it from this week)  
There is time to still give feedback to Agustina about the report, which in turn can be fed back to UKRI.
