

# Courtifa Privacy Policy

Courtifa ("we", "our", or "us") respects your privacy and is committed to protecting your personal data. This Privacy Policy explains how information is collected, used, stored, and shared when you use the **Courtifa** mobile application (the "App").

By using Courtifa, you agree to the collection and use of information in accordance with this Privacy Policy.

## 1. Information We Collect

### 1.1 Personal Information

When you create an account or use Courtifa, we may collect the following personal information:

- Email address (required for login and account creation)
- Password (securely stored using encryption)
- Phone number (optional)
- Profile image (optional)

### 1.2 Location Information

Courtifa may request access to your device's **location** to:

- Detect nearby sports courts
- Sort courts based on distance from your current location

Location access is **optional** and can be disabled at any time from your device settings. The app will continue to function, but location-based features may be limited.

### 1.3 Usage Information

We may collect non-personal information about how you interact with the app, such as:

- App usage patterns
- Feature interactions
- Error logs and crash reports

This information is used solely to improve app performance and user experience.

## 2. How We Use Your Information

We use the collected information to:

- Create and manage user accounts
  - Allow users to book sports courts
  - Allow court owners to create court profiles, set available time slots, and define pricing
  - Display nearby courts based on user location
  - Communicate important updates related to your account or bookings
  - Improve app functionality, security, and performance

## 3. Court Owners' Information

Court owners using Courtifa can:

- Add court profiles
- Define available booking hours
- Set prices per time interval

This information is displayed publicly within the app to enable users to make bookings.

## 4. Data Sharing and Disclosure

We **do not sell or rent** your personal data to third parties.

We may share information only in the following cases:

- When required by law or legal process
  - To protect the rights, safety, or security of Courtifa, its users, or the public
  - With trusted service providers that help operate the app (such as authentication, database, or hosting services), under strict confidentiality agreements

We take reasonable technical and organizational measures to protect your data, including:

- Secure authentication systems
- Encrypted data storage
- Restricted access to personal information
