- i. Lily Bartenstein thanks Aide Suarez and the Youth in Foster Care team for providing copies of their new print materials to share with parents and partners at last month's Building Bridges PTA Council event.
 - ii. Jeanette Navarro has been working with students to get successful college operations
 - iii. James Russel is meeting with high school students and connecting with their principals, developing goals related to job opportunities and planning a PCC field trip
 - iv. Aide Suarez + Lillian Avalos are working on welcome packets connecting new students to resources and teams at school sites
 - v. Dr Reynoso's Update
 - 1. Youth in Foster Care team is going great work!
 - 2. Ms. Avalos has been working on BID meetings and intake process
 - vi. Jeanette Navarro
 - 1. A grant from Pasadena Education council has provided gift cards to incentivize the work that our students are doing
 - vii. Cedric Johnson
 - 1. Working with middle school students on life skills & engaging with the process planning for their future
 - 2. Students he's working with have also been encouraged with gift cards recognizing grades and perfect attendance

 - ix. Student Wellness and Support is working with a donor to make sure all of our seniors are supported in the senior activities, yearbooks, etc.
 - x. Pasadena Mental health under SWS may have a project for students to support Prom as well
- b. PALS
- i. Dr. Hernandez was unable to attend the meeting today, but we will attempt to follow up on the issue for a future meeting.
 - 1. In an email follow up, Dr. Hernandez committed to attend the March and April meetings of the Foster Youth Council.
 - ii. Ruthann advocated for the attendance of staff who can speak to the current and future planning for the PALS program in this meeting. Ruthann described some of the challenges in advocacy for this student population and the need for improvements in our systems and resources to support them.
 - iii. A site visit could be helpful for us to better understand issues related to services provided.

VII. 12:30pm to 12:40pm Committee updates:

- a. LCAP (Local Control and Accountability Plan)
 - i. Lily Bartenstein shared the [summary document](#) of the PUSD LCAP so that members of the council can see the intention and goals that have been included, including the foster youth specific goal and allocations in goal 6. In the case of our PUSD LCAP, a portion of this supplemental funding has been allocated to support staffing the Youth in Foster Care team.

- ii. Kim Kenne - the LCAP document defines goals and metrics to measure, plus actions to meet those goals. These targets should also be aligned with our department plans.
 - iii. The last few pages of the full LCAP show how funding is specifically allocated to action items, and can be a useful reference.
- b. Kim Kenne - Shared about the Board Committee on Child Welfare, Attendance and Discipline, which has as an identified focus the needs of foster youth.
 - i. This committee has had one meeting so far, which defined the scope.

 - ii. Committee reviewed MTSS (Multi-tier system of supports)
 - iii. New policy limits reasons for expulsion and suspension in our elementary schools, so we reviewed the supports we provide to students and teachers, and we want to look at the data and see how the implementation is going
 - 1. RTI wellness teachers have also been added to support school sites, which have provided valuable supports to classroom teachers and school staff
 - iv. Committee is scheduling a meeting in March
 - v. The committee is interested in identifying systemic issues that the board can provide support to address, and seeing how data allows us all to get better
