**Sanction:** In granting this sanction #WI2025-140S, it is understood and agreed that USA Swimming and Wisconsin Swimming, Inc. shall be free from any liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event. **Date:** Saturday & Sunday, February 1-2, 2025

**Location:** Deforest High School Indoor Pool, 815 Jefferson St, Deforest, WI 53532

**Facility/  
Timing System:** Indoor 25 yard pool with eight 7' lanes, non-turbulent lane markers, backstroke flags, 29 1/2" Keifer starting blocks, guttered pool. Pool depth is 12' 6" at the starting block end and 3 1/2' at the opposite end. All 25 yard events will start off blocks, but for 100 yard relays 2nd and 4th swimmers will start in water. The Meet host will ensure the required course dimensions.

All events will be timed using Colorado 6 Timing System with strobe/horn start, touch pads, one button, and 2 watches as backup, with the exception of all 25-yard races, which will be timed with 2 electronic watches and minimum of one button. All events will be timed finals.

**Format/  
Warm Up Info:** Psych Sheet, Warm-up assignments and general meet information will be available no later than Wednesday, January 29, 2025.

Circle swimming only, except in designated lanes and times. All entry to pools during open warm-up cool down periods shall be feet first three-point entry from the start end. No snorkels, kickboards or other training devices are allowed during warm-ups. Teams should plan to do starts, sprint and pace work within their assigned warm-up time. Swimmer(s) without a coach present are to report to the Meet Director prior to warm-ups for lane assignment.

**The 500 Free (Sat) may be limited to 40 swimmers & the 1650 (Sun) may be limited to 24 swimmers.**

All coaches must show current USA Swimming membership cards at the swim meet. Swimmers must be current registered members of USA Swimming and in good standing.

**Entries/Deadline:** Entries will be taken on a first come, first serve basis EXCEPT those who sent in a reservation and check. Swimmers may compete in 4 individual events per day and 2 relays. All teams are requested to submit entries in the Hy-Tek Commlink format. Emailed **Hy-Tek Entries will Open on Wednesday, January 8th, 2025 at 8:00am. Entry acceptance will close on Tuesday, January 20th, 2025** After the reserved entries are uploaded the remaining entries will be accepted in order received until the meet timeline is filled. You will receive an email confirmation of your entry within 24 hours. If you have not received that confirmation, please email Sandy Kuecker at [sandy.kuecker@waunakeewave.org](mailto:sandy.kuecker@waunakeewave.org). A check for meet entry fees, a hard copy of the entry fee remittance, and signed waiver may be sent via standard mail. ***For entries NOT submitted by Hy-Tek Commlink; hard copy, waiver and fees, must be received no later than Monday, January 20, 2025.*** Please notify the meet director and meet referee for any special requirements for disabled swimmers on the entry form.

Entries may be limited by the Meet Director to adhere to USA-S's Rule 205.3.1(F), i.e. the four hour session rule for 12 & Under athletes. A meet timeline and psych sheet will be sent to the email address who submitted the entries prior to the meet.

**Entry Fees:** \$4.00 LSC splash fee per swimmer, \$6.00 per individual event, and \$15.00 per relay, PLUS a \$16.00 fee per swimmer **for facility, admission and heat sheets.**

**Deck Entries:** The entry fee for individual deck entries will be \$10.00 (\$20.00 for relays) in addition to the \$4.00 splash fee, along with \$16.00 facility (if not already collected) for the facility, admissions and heat sheet fee. Deck entries will be allowed to fill open lanes. No additional heats will be added. Deck seeding will close 30 minutes prior to the start of each session.

**Deck USAS Registration:** WAUN will not accept USA-S registration on deck. An unregistered swimmer may not compete.

**Age Groups:** 8 and under, 9-10, 11-12, Open. Age is determined as of the first date of the meet.

**Awards & Scoring:** Individual Events, places 1<sup>st</sup> thru 16<sup>th</sup>: Relay Events, places 1<sup>st</sup> thru 8<sup>th</sup>:

Awards for relay events will consist of ribbons for 1<sup>st</sup>-8<sup>th</sup> place. Awards for individual events will consist of ribbons for 1<sup>st</sup>-16<sup>th</sup> place. Coaches will be permitted to pick up awards at the end of each session or at the conclusion of the meet. Awards will not be mailed.

- Coaches:** All Coaches **MUST** be USA Swimming registered as of the date of the meet. The official mobile application of USA Swimming is acceptable proof of USA Swimming membership. **If a coach does not have a current USA Swimming registration – they CAN NOT be present on the pool deck.** All coaches can pick up their coaches packets at the timing table on the pool deck. **Any monies still owed must be paid before you can obtain your packet.** Please be prepared to show your current USA-S membership and sign in on the sheet at the time you pick up your packet. Entry changes are due in writing to the Administrative Official at the timing table on the pool deck 30 minutes prior to the start of each session.
- Admissions:** There will be NO Admission Fees or Heat Sheet fees collected at the swim meet. All of this has been bundled into our \$16 facility surcharge that will be collected with each team's entry fees.
- Concessions** A spectator/swimmer concession stand and a coaches/officials hospitality area will be available throughout the meet.
- Meet Conduct/ Medical:** Flyover starts will be used. All teams are responsible for the conduct of their swimmers. The Meet Director/Marshall, at his/her discretion, shall remove any swimmers or spectators who behave in a disruptive or disorderly manner.
- Any swimmer entered in the meet, unaccompanied by a USA Swimming member coach, must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- Deck changes are prohibited.
- All injuries should be reported to the lifeguard on duty. Lifeguard staff have basic first aid supplies available if needed. Lifeguards can activate EMS if needed.
- Final Results:** One copy of the Meet's final results will be emailed to the email address designated on the waiver form.
- Disabled Swimmers:** If you have swimmers with special needs, please notify the Meet Director no later than Saturday, January 25th, 2025.
- MAAPP:** All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition. Times achieved by an athlete member at a sanctioned meet who is over 18 years of age who had not completed the Athlete Protection Training (or whose APT training had expired) by the date of the swim, will not be able to be uploaded to SWIMS. These athletes will also be considered "not in good standing" and can be subject to fines under Wisconsin Swimming Policy 11.2.1.
- Video Use:** Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, or locker rooms.
