Remember, it is your responsibility to pay your tuition on time. While Teach For America has negotiated your base-rate, they cannot assist you in managing your payments ongoing.

***The above table does not include books or other course materials - **you will have some additional costs** outside of your base tuition. This also does not include any endorsement course costs should you elect to enroll in the ESL, ESL/Bilingual, or LBS I endorsements at NLU starting your second year.*

REMINDER: If you do NOT submit your prorated, out-of-pocket payment by the due dates listed above, you will NOT be registered for any NLU course(s) that term. Please work with your NLU Student Finance Representative, Dana Lam, if you have any questions or concerns.

IMPORTANT NOTES

If you are interested in the Special Education Learning Behavior (LBS I), English as a Second Language (ESL) or ESL/Bilingual Education endorsement:

In addition to your MAT degree, this will change your out-of-pocket amount above. Both endorsements require five additional courses for 15 total semester hours at \$350/SH. Contact your NLU Graduate Advisor and Student Finance representative to learn more.

If you need to take a leave of absence from the program: You will owe NLU any remaining outstanding prorated tuition and fees due from the terms in which you were registered prior to taking your leave of absence. You have up to **one calendar year** to reenter the TFA/NLU program without any financial consequence. If you elect NOT to return after one calendar year, you will owe NLU the full cost for all courses completed that would have otherwise been covered by your AmeriCorps award. Please work with your NLU Student Finance representative or TFA representative listed below to determine next steps based on your unique situation.

Example 1: You begin Summer 2024, decide to take a leave of absence after Spring 2024, and within one calendar year, you decide to return to the program. You will still owe NLU for the prorated amounts as listed above in this guide (minus what you've already paid) for courses taken in Summer 2024, Fall 2024, Winter 2024, and Spring



2024. You may also have qualified for a prorated AmeriCorps Award amount which may be used toward your outstanding balance as well.

Example 2: You begin Summer 2024, decide to take a leave of absence after Spring 2025, and after one calendar year, you decide NOT to return. You will owe NLU for the full tuition and fee costs (minus what you already paid) for courses taken in Summer 2024, Fall 2024, Winter 2025, and Spring 2025. See below for breakdown.

If you exit or are dismissed from the program by NLU and/or TFA: You will not be granted AmeriCorp Award monies and/or will not be eligible for NLU's prorated amount (depending on the time of release/exit). In the event this occurs, you will owe NLU the remaining amount of your tuition and fees that would have otherwise been covered by your AmeriCorps Award.

Example 3: You begin Summer 2024 and decide to leave the program after Summer 2025. You will owe NLU for the full tuition and fee costs for courses taken in Summer 2024, Fall 2024, Winter 2025, Spring 2025, and Summer 2025 – minus what you already paid *and* the AmeriCorps Award received in July 2025. See below for breakdown.

UNDERSTANDING YOUR BILL & HOLDS

NLU sends out automatic monthly tuition & fee bills via email on the 15th of every month to all NLU students across the university. Your bill will **not** simply show your out of pocket balance due each term. Rather, your bill will reflect the **entire** account balance of tuition and fees accrued. It is imperative that you refer to this TFA tuition guide regarding your **actual out of pocket balance due each term**, of which Student Finance is aware. **Payment is due the first week of the term.** If you choose to take additional coursework not included in your M.A.T. cohort sequence (ex: ESL coursework), the amount of the additional classes will be due in full each term.

NLU does place holds on all NLU student accounts if students do not have a zero balance (irrespective of payment arrangement/type). **If you are not current with your out-of-pocket balance due, you can be unregistered for NLU courses for the upcoming terms.**



IMPORTANT: NO transcripts, diplomas, or certification (including your teaching license) will be processed until you have an account balance of \$0.00.
