Hello, I am a Taino man. I am here to tell you about the historical things Christopher Columbus did to me and my people during the time of his second voyage to Hispaniola. He and the rest of his Spanish soldiers were savages. When they first arrived to we tried to treat them with kindness and respect. We allowed them into our homes and fed them. We taught them about

us. They showed us things we had never seen before. Different tools and utensils they walked around with. The tools looked dangerous, but my people were afraid to ask about them.

They showed us thick, rectangle like things things, filled with many thin slices of a solid lightwei ght material. It had black scribings in rows. They called it the Bible. My people had now idea what the scribings meant, but it was clearly very important to the Spaniards. They tried to teach us about the thing and some man named God. We didn't understand what they wanted us to learn about their God and the thing. Soon they became very angry about us not understanding. They attacked us and did very horrible things. They tried to show my childhood friend about the thing, but he didn't know what was going on. In retaliation for him not complying they imprisoned him, his wife, his parents, and his two kids. They took his mother, wife, and daughter and raped them. I can hear their screams ringing in my ear till this day. They stripped them, beat them, and killed them using their strange tools. This upset my people. We tried to drive them out and make them leave our home, but they turned into animals. They killed everyone. Man, women, children, even babies. This was very painful to watch this happen. My people attempted to fight back, but we weren't strong enough. As everything quickly demolished the Spaniards stopped killing and starting holding my people captive. They put them on the giant things they arrived on. Many were taken and many were dead

I believe that their leader Christopher Columbus is at fault for the death of my people. O have know idea why they would do such a thing like this. He tried to comply and reason with them, but they didn't want to hear it. They made no effort to understand what we were about what so ever. They need to be brought to justice.

My name is Akua Asya and I am a african slave that was brought to the caribbean on behalf of the decision of Bartolome De Las Casas who told Queen Isabella, and King Ferdinand to use african natives such as myself as a replacement for the Taino tribe, and any other indigenous people from that area. Not only was I forced to leave my home I was also separated from my family and all my friends. My whole world was turned upside-down. We were the replacement for those that already felt the pain and suffering of columbus and his men. They were already exterminated, almost all of the taino and other tribes had been murdered. Either by columbus and his crew, or by committing suicide to escape a more horrible death by the hands of columbus. Would want to end your days on earth by being brutally abused, and then exterminated in front of your family as an example? I think not.

Not only did they force us to do their bidding and supply them for their benefit they also tried to change our ways of life. Couldn't they even have a little remorse for our ancestors and culture? We were forced to learn their language and had to be become christian catholics at that. All of our mature men and women are dead, do you know anyone else who can pass on our genes, knowledge and love? Sometimes I stay up and cry, but I don't cry because of the physical abuse. I cry knowing that their are african mothers giving birth to more children this very moment. These women are like breeding machines, columbus and his men only want more. These children will grow up and can only look and the graves of their brothers, sisters, parents, aunts, uncles and so on. They will grow up with a twisted view on reality, that they only work for columbus and his men, and nothing else. Death doesn't seem so bad right now does it? I can see why mothers sacrificed their children, so that they wouldn't have such a horrible life. This

eternal nightmare was caused by columbus, his men, king ferdinand, and queen isabella. I hope you can clearly see as day why we accuse them of these charges. I think that it's funny how these people are actually being praised by many people, columbus even has a holiday. It feels as if you're commanding a demon.

Hi, I'm a Spanish Soldier for the man Christopher Columbus himself. I'm here to tell you MY story on MY experience on the things we did when we got to that great land we found those Tainos on. Firstly, it was not my choice for what we did to those Indians, I was ordered by Columbus do to all the things we did. I will not lie though, I did enjoy what we did to them. Columbus's goal was to take them out of their own land and we achieved that goal.

Columbus said himself, "Should you fail to comply...we assure you that with the help of God we shall use force against you, declaring war upon you from all sides and with all possible means and we shall bind you to the yoke of the Church and their Highnesses; we shall enslave your persons, wives and sons, sell you or dispose of you...we shall seize your possessions and harm you as much as we can as disobedient and resisting vassals". And so we did. Killing them was so easy. It was like they were defenseless, not knowing the proper way to battle. To me, it was like a fun practice fighting session.

It was such an amusing time. This was one the few directions I got from Columbus that I actually enjoyed. We placed bets on who could cut a man in half with one swing. We swung babies into stone walls with no remorse then kill the parents. We laughed in the faces of babies as we threw them into the rivers. "Boil there, you offspring of the devil!" We would yell as we

threw them. The indians tried fighting us back with their weak weapons and that only made us laugh and more blood hungry. Anyone who dared to fight back we did not spare nor hesitate to strike them with our swords. Do I still look back to those days? Absolutely. But do I regret anything I did, NOT A CHANCE.

## **Closing Statements:** (Jordyn and Neissa)

1. For most of history, columbus has always been depicted as a hero who "discovered" the Americas and brought the world together, but really, he brought many people into oppression and brought genocide on to the native people of the americas.

Though this has caused people to look at him differently, many americans, out of patriotism, have decide to ignore this. He raped tortured, stole, and separated people from their homes and families.
