This page is used to inform visitors regarding my policies with the collection, use, and disclosure of Personal Information if anyone decided to use my Service.

If you choose to use my Service, then you agree to the collection and use of information in relation to this policy. The Personal Information that I collect is used for providing and improving the Service. I will not use or share your information with anyone except as described in this Privacy Policy.

### **Information Collection and Use**

For a better experience, while using our Service, I may require you to provide us with certain personally identifiable information, including but not limited to yangbinkaka. The information that I request will be retained on your device and is not collected by me in any way.

The app does use third party services that may collect information used to identify you.

### **Log Data**

I want to inform you that whenever you use my Service, in a case of an error in the app I collect data and information (through third party products) on your phone called Log Data. This Log Data may include information such as your device Internet Protocol ("IP") address, device name, operating system version, the configuration of the app

when utilizing my Service, the time and date of your use of the Service, and other statistics.

## **Cookies**

Cookies are files with a small amount of data that are commonly used as anonymous unique identifiers. These are sent to your browser from the websites that you visit and are stored on your device's internal memory.

## 1.2 Collected for service purpose

You can use this software without a user account. If you want to use more functions, you can register this application and provide relevant personal information. The information collected by "Dylect" is limited to the information necessary for you to agree to use the basic service.

## 1.3 User provided

1.3.1 If you need to use more "Dylect" functions, such as sharing the content of "Dylect" on WeChat, Weibo, etc., you need to complete your personal information, such as filling in your gender, birthday, car model and other personal information.

1.3.2 The information you provide, "Dylect" will maximize the reasonable commercial obligations to keep confidential. With your consent, "Dylect" will provide you with information notifications, event pushes, version upgrades and other services.

## 1.4 "Dylect" is a tool used to send information and other content between users

If you send information or other content to another user, the "Dylect" server will save this information/content for you and send this information/content to that user.

## 1.5 Other ways you provide information

We may collect your personal information in other ways (for example: email, information download, purchase of products or services, feedback). If you fill in your personal information on other open platforms, other users may learn your information.

## 1.6 Information you share to the community

All the information you share in the "Dylect" community (including but not limited to photos, videos, etc.) is open to all viewers by default. You must be responsible for all actions under your registered account, including any content you send and Any result from this. "Dylect" cannot and will not be liable for any losses caused by the user's own actions. In order to avoid legal risks, users are not allowed to use "Dylect" to create, upload, copy, or send the following content:

- a. Oppose the basic principles established by the Constitution;
- b. Endangering national security, leaking state secrets, subverting state power, and undermining national unity;
- c. Damage to national honor and interests;
- d. Inciting ethnic hatred, ethnic discrimination, and undermining ethnic unity;
- e. Undermine national religious policies and promote cults and feudal superstitions;
- f. Spread rumors, disrupt social order, and undermine social stability;

## 1.7 Your other information

In order to facilitate your use of the "Dylect" software, our server will collect information about your mobile communication device, such as model, device ID, Internet protocol address, time and location of your visit, routing data packets, sender of information and receiving data (But not the information itself), and other similar characteristic records. We will use cookies and navigation data like Uniform

Resource Locator (URL) to collect the time and date of your visit, search and view information, etc.

## 1.8 location information

Information about your location collected when you turn on the device positioning function and use our location-based related services.

include:

When you use our service through a mobile device with a positioning function, your geographic location information is collected through GPS in order to obtain the wifi name of the relevant device.

You can stop the collection of your geographic location information by turning off the positioning function, but this will affect the acquisition of the wifi name by our APP.

## 2、Use of personal information

2.1 If this privacy agreement does not specify or the update of this privacy agreement fails to notify you, your personal information will not be used for other purposes.

2.2 Anonymous aggregate statistical data is not personal user information as defined by "Dylect". We will store and use such information for a variety of purposes, including but not limited to analysis and usage pattern reports. "Dylect" reserves the right to allow third parties to use and disclose anonymous aggregate statistical data for any purpose or unilaterally.

2.3 All the information you share in the "Dylect" community (including but not limited to photos, videos, etc.) is disclosed to all viewers by default, and may be copied, forwarded, altered or used for other illegal purposes by other organizations or individuals. Will damage the legitimate interests of you or others, and you must be fully aware of the existence of such risks. You expressly agree to bear all risks and consequences of sharing information by yourself, and "Dylect" does not need to bear any responsibility.

## 3、Disclosure of personal information

3.1 Except for the limited disclosure stated in this privacy agreement, we will properly store your personal information and will not disclose the list of customers.

3.2 You hereby authorize that, in the following circumstances, we will disclose your personal information to a third party without your consent:

3.2.1 It is necessary to identify, contact or file a lawsuit against actions that may cause damage to our rights or property, users or any other person (including the rights and property of any other person);

3.2.2 The need for legal investigation;

3.2.3 It is necessary for subpoenas or other warrants issued by law enforcement agencies to be served to us by law

3.3 For the purpose of sharing interesting videos or warning viewers to pay attention to traffic safety, "Dylect" may forward the information shared by users to the community (including but not limited to photos, videos, etc.) to third-party platforms. The user continues to use the software to agree to "Dylect" forwarding to third-party platforms.

#### 4、assist

You should assist us to protect the security of your personal information. For example, don't reveal your personal password.

#### 5、Collection and use of personal information of young people

5.1 We recommend that minors under the age of 18 use "Dylect" with the permission and guidance of their legal guardian.

5.2 "Dylect" will not use the personal information of minors, nor will it disclose identifiable information to any third party. The guardian has the right to refuse "Dylect" to further collect the personal information of the ward, or request "Dylect" to delete the ward Personal information.

#### 6、Amendments to this privacy agreement

6.1 This privacy agreement allows adjustments. If we make any substantial adjustments to the method of using your personal information, we will notify you through an announcement.

6.2 If you do not want us to change the use of your personal information, you must notify us before you expect to stop using our account. Your continued use of "Dylect" will be deemed to be that you know and agree to be bound by such changes in the notice.

## 7、Permission description

7.1 The purpose of obtaining the ACCESS\_FINE\_LOCATION and ACCESS\_COARSE\_LOCATION and ACCESS\_BACKGROUND\_LOCATION permissions is to obtain the geographic location when the WiFi name is obtained.

7.2 The purpose of obtaining CAMERA permission is to take pictures and record videos.

7.3 The purpose of obtaining INTERNET permission is to access the device server.

7.4 The purpose of obtaining the WRITE\_EXTERNAL\_STORAGE permission is to store the video or picture files passed by the dash cam.

7.5 The purpose of obtaining the READ\_EXTERNAL\_STORAGE permission is to read the pictures or videos in the local album when posting.

7.6 The purpose of obtaining the ACCESS\_WIFI\_STATE permission is to check whether the user's mobile phone is connected to the Internet.

7.7 The purpose of obtaining the READ\_MEDIA\_IMAGES permission is to store the picture files passed by the dash cam.

7.8 The purpose of obtaining the READ\_MEDIA\_VIDEO permission is to store the video files passed by the dash cam.

7.9 The purpose of obtaining the POST\_NOTIFICATIONS permission is to obtain notifications of app version updates.

8.0 The purpose of obtaining the NEARBY\_WIFI\_DEVICES is to obtain the geographic location when the WiFi name is obtained.
