#### **Affordable Housing Advisory Committee:**

**From Chair, Barry Bialik:** I recommend Nnweyna Smith to the vacant AHAC seat. I recommended her last time as well, and she was not appointed. I feel her diverse background would add the most balance to our current committee makeup. If she was not available for appointment by some chance, I would recommend Jessica Phelan.

#### **Design Review Committee:**

**From Chair, Robin Rainers:** I feel that Thomas McLaughlin would make an excellent candidate as well as Maria Delsasi. I don't particularly see a problem with any of the candidates except for Lauren McKinney who lives in Arden.

# **Homeless Initiative Advisory Committee:**

The HIAC nominating workgroup would like to recommend Rick Freeman and Andrew Garrard for the two open seats. Neither specifically fills one of the sectors on our matrix, but the workgroup felt both represent key community voices since Rick is the president of CAN and very involved in his own neighborhood association and Andrew is a realtor so represents both the business community and housing sector.

#### **Noise Advisory Board:**

**From Staff**: Staff would like to recommend Maria C. Burril. Being from Asheville, Maria has seen its changes over the years. With her background in real estate, she could bring a unique perspective to the Board.

From Chair, Jessica Tomasin: My recommendation for the restaurant seat would be Lilianna Wood and for the resident position my recommendation would be for Reb Haizlip or Jeffrey Fromson. Reb seems to have experience in the science of sound and acoustics which I think is important and I think Jeffrey would be helpful in the area of compromise and has looked into noise issues in other cities.
