Attendance

In NSW, education is compulsory for children aged between 6 and 17 (as defined by the **NSW Education Act 1990 Section 21B**). All students are expected to attend all scheduled, school classes, and activities every school day of each term. School attendance helps children develop social skills, such as friendship building, teamwork, communication skills and healthy self-esteem. Also, as most learning occurs sequentially, absences have a compounding effect.

Although, as you can see, as a school St John Paul II is above the CEDP average we are not meeting the 90% target. A quick glance at the attendance levels for each year group will tell you where the deficit lies.

Your Role as Parents

- Ensuring that your child/children attend school every day.
- Ensuring that your child/children are punctual to school.
- Explaining the absences of your child from school promptly by means such as a telephone call, written note, text message or email to the school within 7 days of the absence.
- Work in partnership with the school to plan and implement strategies to support regular attendance at school, including communicating with the school if you are aware of issues impacting your child's attendance or engagement with school.

Uniform

Our College community takes pride in our uniform and as a result, we have strict expectations and guidelines around professional attire for our students. Our uniform identifies us as members of the same community and ensures the students are well dressed in a professional manner, whilst meeting the WHS requirements.

We ask families to support the College with our professional attire and to ensure all students are dressed appropriately for school with the correct uniform each day.

Please spend some time with your child to read through pages 23, 24 & 25 of the College planner to better understand the College uniform requirements. Some items to note:

- Long hair must be tied up.
- Extreme haircuts are not permitted. These include mullets/eshay fades, undercuts, scalp designs, mohawks etc. Boys should have nothing shorter than a number 2.
- Hair must be one natural colour.
- No piercings on any part of the body, with the exception of girls having one set of earrings (small plain studs or small plain hoops) in the lower ear lobes. No covers or plastic keepers/spacers.
- The College blazer should be the outermost garment when the winter uniform is worn. It is the expectation the blazer is worn to and from school during Terms 2 & 3.
- Sports jackets can not be worn with the summer or winter uniform. Students must wear the red jumper or blazer with their summer or winter uniform if they are cool.
- Hoodies/Jumpers with hoods are not part of our uniform. Coloured jumpers/jackets are not permitted.
- Students are required to wear the correct footwear each day. Please see the infographic below for more information around College footwear requirements.

The appropriate school shoes are a requirement of the school uniform. The college uniform identifies us as members of the same community and ensures students are well dressed.

- When the correct shoes are worn, students satisfy WHS requirements and look professionally dressed.
 - Please use this as a guide when preparing your child's uniform.
 - Please note that students will be asked to purchase new shoes if they are not wearing school or sport shoes that requirements of the college uniform code.

VAPING - a Dangerous Trend

As a College we are committed to ensuring the health and safety of your child/children. To this end we remain vigilant in our efforts against vaping at school. Unlike traditional tobacco products, vape is often sweet smelling or odourless. Some vapes are even vapourless. This makes the job of catching culprits very difficult. Below is valuable information to help you better understand, 1) the health risks associated with vaping; and 2) the insidious nature of the practice.

Understanding the Health Risks Associated with E-cigarettes and 'Vaping'

E-cigarettes are battery-operated devices that allow the user to inhale chemicals in a vapour form (known as 'vaping').

Across the media there have been reports of teenagers displaying risk taking behaviour through the use of e-cigarettes. Unfortunately they are not a safe alternative to smoking as they can have some very harmful side effects. All e-cigarettes are illegal for children under 18 years. Unfortunately some students have been suspended for e-cigarettes.

It is important for parents to know what the law says regarding e-cigarettes and 'vaping' in NSW.

- All e-cigarettes, regardless of whether they contain nicotine, are illegal in NSW for people under the age of 18.
- Under the NSW Public Health (Tobacco) Act 2008, it is **illegal to sell e-cigarettes** or e-cigarette accessories to a person **under 18 years of age**.
- The sale and use of **e-liquid nicotine**, including in e-cigarettes, is **against the law for everyone including adults**
- E-cigarettes that do not contain nicotine are legal in NSW for Adults (over the age of 18). Adults can buy and use e-cigarettes that do not contain nicotine.
- The Smoke-free Environment Act 2000 and the Passenger Transport (General) Regulation 2017 prohibit people from using electronic cigarettes (or e-cigarettes) in smoke-free areas.
- It is illegal to display, advertise or promote e-cigarettes.

CEDP has a very clear policy regarding "**Banned Substances**" (cigarettes, e-cigarettes, alcohol, drugs). The policy states that *"CEDP schools must be places that are free from the possession, use or distribution of banned substances."* Therefore, in terms of e-cigarettes, students are prohibited from:

- possessing (having an e-cigarette)
- using ('vaping' from an e-cigarette)
- distributing (giving or selling an e-cigarette to others)

Please note that e-cigarettes with nicotine are treated as an illegal substance such as illicit/illegal drugs. There are very serious consequences for students who break the Banned Substances Policy. These include:

- Parents contacted
- Police contacted (where there is a possible concern of any illegal activity, distributing, selling or nicotine based e-cigarettes etc.)
- Suspension
- Other consequences deemed appropriate by the College Principal, or NSW Police.

eSafety - TikTok (Social Networking Site)

Recently we have been working with several families regarding serious issues related to the use of TikTok at home, especially with students under the age of 13.

TikTok is a free social media app that lets you watch, create, and share videos, often to a soundtrack of the top hits in music using a mobile phone. However, with so much information out there, it can be a challenge for parents/carers to know if it is really safe.

Because of TikTok's emphasis on popular music, many videos include swearing and sexual lyrics, so it may not be age-appropriate for your daughter to use on her own. It is also easy to find people wearing revealing clothing and dancing suggestively/inappropriately.

TikTok requires that users be **at least 13 years old** to use the full TikTok experience. **Anyone under the age of 18 must have approval of a parent/carer.** If your daughter is under 13 years old and wants to use the TikTok app, there is a section of the app that includes additional safety and privacy features. This under 13 version of TikTok uses clean videos and users are not allowed to comment, search, or post their own videos.

If you allow your daughter over the age of 13 to use TikTok, we encourage you to share an account with her. This will allow you to keep your daughter safe by monitoring what she daughter is viewing and posting.

As with all social networking sites we encourage parents/carers to ensure they are monitoring their use at all times and are aware of any legal or social impacts when it comes to its misuse. We encourage parents/carers to keep open communication with your daughters to ensure that they can report any concerning posts to you. If any social media post contains any violence, threats or other illegal material, please report this to NSW Police immediately.
