Agenda item C- Worship and Music- Celtic service will be the next special service.

Agenda item D-Alter Guild-Carol Conrad spoke for group. The plastic covers on the altar are no longer used. If anyone would like to join, they would be most welcomed. There is plenty of help and the schedule is not set in stone so there is no worry in finding a substitute.

Agenda item F- Sunday Church School- All agreed that we love when the children sing. Thank you Mona and Becky. Thanks to Yolanda for her work with the high school group.

Agenda item G-Outreach-Thanks to all who contribute in any way. A mention was made that this year we collected over 200 lbs. of clothing and that diapers are always needed. Our sister church in Tanzania is hoping to build an addition. Hopefully, our efforts can help with this. Lastly, the Meals-to-go will be assembled in April.

Agenda H-Property- Harry sends greetings from Florida! The big project this year was the shingles. The workers have to come back in April for the final coating. The sills need a little work too. The work was paid for thru the maintenance and memorial funds. Thank you Harry for your steady and dependable efforts at our church.

Agenda item K-Fun Raisers-The Scandinavian items are sold throughout the year and at several events. Half of the proceeds go into the budget and the other half is kept to purchase the inventory. Lenny Kogos asks if we can let the public know that we have these items. Jennifer Williams sends letters to area Lutheran Churches to let them know about the sales.

Agenda item J-In-reach – Next up are the Lenten cluster devotions and May trip to NYC.

Agenda item M-Endowment- Larry Pion fields questions. Stan Jefferson is chairman. The committee meets 3-4 times a year to make any changes. Money is taken out two times a year for the operating budget. We have a 5% spending rate. The principal cannot be touched.

Budget: 2015 Proposed budget-Some of the line item increases were discussed. The salary increase for David and Jennifer were approved. The long-term maintenance fund was increased by \$1,000. The parking lot was done in 1968 and about eight years ago some cracks were filled.

A motion was made by David K. and seconded by Yolanda C. to accept the budge as amended. Motion passed.

Marshalled enjoyed reading and sharing his latest find with me and others in the church. Millie's heart was of gold as she always volunteered at church for everything. It is not overstating the point that Millie's life centered on the church. She will always be known for her caring and compassionate spirit. I can hear Louise's cheerful laugh as I write these words. Louise was a most humble woman. For the last many years she lived at the Buckley Nursing Home. There she was a cheerful, caring woman for whom the staff cared for much. Before those years she was always early to arrive at church and take her familiar seat in the back. I will miss them all!

This was also a year with many people concerns, our prayers were filled with the names of many from our family and friends of the St. Paul's family. We keep many in your prayers as they struggle with many health concerns.

Our church family continues to grow and we are grateful for the energy and commitment that our new members bring to St. Paul's. We welcomed Rachael Mason, Lucie Mason, and Julie Gilfeather-Girton.

Our picture board looks great. Larry has his camera at church on Sundays and it ready to take your picture or update your picture. The years reveal changes, so there is a need to update several pictures. Just let Larry know when you might wish to have an updated picture or perhaps your first picture.

I consider myself blessed by you and I am certainly aware of your good feelings toward me and my ministry with you. It is because of you that St. Paul's is such a wonderful church family. I look forward to our shared future in service of a most gracious God, one whose grace I especially feel at St. Paul's. Thanks for your kindness that overflows and overwhelms!

As always St. Paul's was an active church because you were there to help in all the many programs and activities undertaken by the church. Each of you has your own area of interest and I rejoice in your willingness and eagerness to share your time and talents with all of us.

2015 witnessed the continued good work and growth of the Helping Hands Fund. You all should be proud that our church can be there for others to help in their times of need. Let me assure you that the needs are great. This year we were able to provide over \$1,500 in support to those in need. I encourage you to think about a special gift to this fund. You may do so by indicating Helping Hands Fund on your check.

Our outreach/service projects this year included our continuing collections for take-out meals for the community meals program, and the collection of aluminum tabs for Children's Hospital in Springfield. Our periodic collections included a collection of cash for world hunger, a collection of household supplies for the shelters in greater Greenfield, a collection organized by the high school class of personal care kits for the Family Inn in Greenfield, a collection for health kits for Lutheran World Relief, and a collection of winter clothing for the homeless families who have been relocated to the hotels in Greenfield. We are also collecting diapers for the families in the motel shelters. This year was also special collection for the purchase of building brick for our sister church in Tanzania. The response to all of these was overwhelming! Thanks to all for your help and participation.

Our High School students continue to take turns cleaning the church. I am delighted with this arrangement. First, the church is very clean. Second, all of the high-schoolers have an opportunity to earn \$30 a week. Third, this activity creates a sense of belonging and responsibility for our fine young people. Many thanks to our high-schoolers!

During the year we continued to make use of email updates and our website with our weekly newsletter and readings. The newsletter includes archives of movies and pictures. For those not receiving a web delivered newsletter, copies are available in the box above the table in the narthex. This use of email allows us to save considerably on postage and helps us to keep folks informed about people and events in the church. Worship and Music at St. Paul's is exceptional.

At St. Paul's we are blessed with fine vocalists and instrumentalists. Many thanks to Corki Demers who inspires us and guides us in our worship each week. Her leadership of the choir is a wonderful gift. She gives from her heart to guide our worship. I am so pleased that the council in its 2016 proposed budget has added Corki as a paid member of our church staff. She is joined by Terry Atkinson who faithfully devotes herself to our music program and adds much with her awesome voice and guitar skills. We are all grateful. The two are a blessing to us all. David King dazzles us each week on the organ—should I say two organs as David moves between the wonderful Estee reed organ and the larger electronic organ. How blessed we are with David—his musical offerings each week are a wonderful ministry to us all. Thanks also to Mona Pion who has worked with our young people to prepare a song each month. This year we celebrated our tenth Celtic service and our tenth Blue Grass service—certainly musical highlights. In August we added a special liturgy for laughter Sunday. At the Christmas eve service this year lighted candles returned to the welcome of all. If though I was nervous, I must say it was beautiful and inspirational. I am looking forward to what new blessings the choirs will have for us in 2016.

Many thanks to Wayne and Margaret for their willingness to take turns doing the sermon. Wayne is a "regular." He preaches the second Sunday of each church season and in July.

Our children are a blessing to us and the many who volunteer to teach are a blessing also. An important part of St. Paul's mission is the education of the young. In today's world the pressures on our young people are great. I am pleased that we have an opportunity to offer to our young people a spiritual vision of the world. One aspect of the spiritual vision is caring for others. This year Mona with the help of Becky has done a marvelous job leading our SCS. Our schedule is working: The children age 3 years old to 3<sup>rd</sup> grade will meet downstairs after the Red Basket lesson. At 10:00am the kids meet downstairs to work on the song which they will sing on the first Sunday of each month. Grades 4-12 continue to meet each Sunday. Our children also enjoy many activities throughout the year. Thanks to all those who volunteer to help and contribute to our Youth Fund.

It is such fun to see all the children at our many gatherings. Thanks to many of you who helped with our youth activities. I am so pleased that we can involve our youth in a variety of activities and truly appreciate your help.

In May we had a wonderful trip to NYC to a wonderful meal in Chinatown and an emotional visit to the 9-11 memorial. This year plans are not yet complete, but we may still be able to see an off Broadway show or take a trip to Maine and the Marginal Way. First Choice Tours is working on the possibilities.

In August, we again rented a motor coach for the high school Boston trip. The trip was open to all in the church and the buss was full! Our trip took us to the zoo in Boston, Quincy Market, and Harvard Square. It was a full and rewarding day. Our driver was exceptional!

Maintaining our property must be a top concern. Harry Hoyer deserves many thanks for his continued leadership in managing the property concerns at the church. Thanks to all those who cared for the lawn and cleaned up the leaves. Our exterior staining project is not yet complete. A second coat will be needed in the spring. In April we had a very successful spring clean and will have another this April. A special thanks goes out to Jim Carpenter for the gracious donation of our new outdoor shed. We certainly needed the storage space. Steve Tomi has made good use of it with his frequent and thoughtful use of our outdoor tools with the result that our grounds look great.

Our fun raisers were all very successful this year. I know that they are building on successes from previous years. So many hands made these events possible. Our tag sale was a great success—it is never too early to start collecting!! Organizing the tables according to item type and having everyone price their items saved us much time. Sara did a marvelous job of giving the basement a true department store feel. Our spaghetti supper was a big hit and again thanks to all the helping hands and the great work of a fine crew guided by Debbie Mumblo. We received many great reviews for the way our young people helped as servers at the meal! Kathy Zimmerman did a fantastic job in coordinating the Craft Fair and the addition of the Swedish items thanks to Cathy Nelson and Bonnie Johnson was a plus. Thanks to Harry and his German sausage crew for making these tasty sausages available at the Tag Sale and Craft Fair.

It is such a good feeling that we can end the year again in the black, for it is very frustrating when we cannot pay our bills. Keeping track of everything and paying all the bills, however, takes a lot of time and effort. Cathy Nelson continues to bless us with her diligent and careful work as financial secretary. Thanks also to Jennifer Williams our treasurer who pays the bills and manages many of the "forms" we are required to file. Jennifer uses Quickbooks for our financials. The monthly reports are posted in the hospitality room and on the weekly newsletter page (check the left margin for the link). The Endowment Committee have done a great job of managing the church's endowment funds.

Carol Conrad continues to do a great job for all of us in leading the altar guild and making sure that each Sunday we are ready for our worship. She coordinates many volunteers and maintains all of the necessary supplies. I know that she would appreciate anyone who would like to volunteer for a month.

The church council has served us all very well and deserve thanks. A special word of thanks for Terry who has served as our council and congregational president-- what a great job she has done. Terry has now completed two three year terms on the council and will be retiring for I hope only a short time. Also retiring after much great service to the church is Bonnie Johnson and Stan Jefferson.

I am especially thankful to Terry for encouraging our Green initiative. We now compost what in the past we simply threw away! Terry obtained a grant for the church to help in sustainability efforts. Each week the compost, trash, and recycles are weighted and added to a spreadsheet which you can see by clicking on the left side of the weekly newsletter. The results are impressive! A special thanks also to Lenny Kogos with the help of Annemarie who each week take all of our compostables and trash to the dump where there is a large compostable station.

However, Jennifer is more than those titles, for she serves St. Paul's in a host of ways, faithfully working quietly behind the scenes providing a steady and welcome voice to help guide me with wise counsel and to serve as a sounding board. #### D. Altar Guild, Carol Conrad

What we do: Each month of the year an individual or a couple sets up the altar for Sunday worship and straightens up after church. On communion Sundays, duties include setting up for communion in addition to the regular set-up. Basically, that's it. We substitute for and assist each other as needed-- no problem. This is a good way to serve the church and help Jeff, since without the Altar Guild Jeff must assume all the above responsibilities. Muffins for Mom had many new helpers in the kitchen and setting the tables and they all did a great job. Each year St. Paul's has more people, not only attending its activities but, taking part in them and making them a success. #### F. Sunday Church School, Mona Pion

Sunday School classes resumed at St. Paul's on September 13th and were followed by our annual Rally Day Picnic. A large and diverse group of our church families attended and we all enjoyed an afternoon cookout, sharing fellowship, swimming and a great time together. Thank you Janet for sharing your home for this event.

The Red Basket Youth Choir has resumed and sings on the first Sunday of the month. The Sunday School children have again chosen Heifer Project as their community service program to support with their Sunday School offerings. They chose three animals to purchase this year and we will need to raise \$650.00 to reach their goal. We plan to hold a car wash in warmer weather and also start a can and bottle drive to supplement the weekly offerings. The Confirmands will assist by sorting and rinsing the returns to be turned in. In May, we will travel to the Heifer Farm, located in Rutland, Mass, to see how their funds are used to purchase, care and then send the animals to needly people throughout the world.

We currently offer four Sunday School groups at St. Paul's. They are the Red Basket Group, The Acolytes, the Confirmands, and High School Group. The red basket group is made up of our youngest church members. The acolytes assist Pastor Jeff in the service by lighting candles and participate in the communion services and special church services at Christmas and Easter. They have also assisted as servers at our annual Spaghetti Supper. The confirmands have begun their first year of a two year program taught by Pastor Jeff and meet with him on Sunday mornings at 9:15am. They have assisted with serving at the Empty Nester's Luncheon and have helped serve at Community Meals. The high school group's community service project continues to be preparing bag lunches to be distributed at the Community Meals. Assisted by the confirmands, they continue to collect and sort food items to prepare take home meals for the Community Meals Program. Each year we try to prepare between 750 and 1000 bags lunches as the need continues to grow. Check the newsletter for a list of items needed to prepare these meals.

Becki and I would like to thank all of the parents, volunteers, and teachers who continue to assist with our Sunday School Program. Our wonderful teachers this year include: Arianna White and Zach Howes, Mike Hayden, Samantha Curtis, Yolanda Campbell, Becki Burleigh-Howes, and Mona Pion. There is always a need for volunteers to assist with our many church school programs: the Halloween Party, the Christmas Party and Pageant, Lenten and Easter programs. Speak with Becki or Mona if you would like to assist or teach at some time.

Two final thoughts for my report this year: I would really like to thank the high school group and Yolanda for the wonderful job they did in creating a fun Haunted House for this year's Halloween Party. #### G. Out-Reach

Thank you for your continued support of our outreach programs. During the year we are involved in many outreach program including collection for Community Meals, and world disasters. Further we collected over 700 pounds of food and household goods for the sheltering programs in our area; collected monies for world hunger and the community meals programs; collected diapers for the children who are residing in the motels in Greenfield; collected gloves, mittens, winter clothing and hats for the homeless who are residing in motels in Greenfield; many pounds of personal care products for the Greenfield Family Inn; and made over 60 health kits for Lutheran World Relief. Thanks to Anne Cernak for mailing the health kits. The high school class assembled over 700 lunches for the community meals program. A highlight of our year was the gift of bricks to our sister church in Tanzania for their new education wing.

Here is a list of our various out-reach projects.

## **On-going Programs**

**Collection of aluminum tabs.** The tabs are used by Children's Hospital for the purchase of medical equipment. You may place your tabs in the jar on the table in the narthex.

**Collection of nonperishable food for Community Meals Program.** The confirmation and high school classes collect nonperishable food for the ongoing project of supplying take home bag lunches three to four times a year to the Community Meals Program. Items include fruit cups, instant soup, small packet beverages, snack size cheese and peanut butter crackers, and so on. You may place your items in the baskets located in the picture board room.

**Helping Hands Fund.** Contributions made to the Helping Hands Fund are used for those needing help with food, utilities, medicine, and so on. The Fund disburses on average \$2,000 a year. The need is great. You may contribute to this fund by indicate Helping Hands Fund on your check on envelope.

#### **Periodic Programs**

**Fill the House (mid-July through August).** The collection of household goods (bleach, laundry detergent, cleaning liquids, baby wipes, diapers and so forth for the sheltering program in Greenfield.

**School Kits or Health Kits (mid September through October).** The acolyte group will assemble your contributions and send to Lutheran World Relief.

Winter Clothing (mid November through December). The collection of winter clothing stayed local this year, going to the homeless families living in the local motels.

"Souper Bowl" (First Sunday in February). Cash collection for the local Community Meals Program.

**World Hunger Appeal (Lent).** Cash collection during the Sundays of Lent for the Lutheran Church world hunger programs.

**Person care items for Family Inn (May and June.)** A collection of personal care items for the Greenfield Family Inn-shampoo, hair conditioner, combs, hair brushes, nail clippers, nail files, hand soap, children bubble bath, razors for men and women, shaving cream, deodorant. The items are sorted and delivered by the confirmation and high school classes.

**Heifer Project (Sunday School Year).** The offerings of the Sunday Church School children support the Heifer Project—the gift of animals to help communities oversees become self-sufficient.

#### M. Endowment Committee, Stan Jefferson

The following members make up St. Paul's Lutheran Church Endowment Committee: Mike Hayden, Larry Pion, Erich Hoyer, Bill Walker and Stanley Jefferson, chairperson.

We met a few times this past year reviewing our General and Parsonage accounts. No changes were contemplated and we continued to have our 5% annual withdrawal transferred directly to the churches operating fund by wire.

The Endowment Committee manages two Funds: \*The General Fund\* has 6 Mutual Funds and about 7.9% in cash and cash equivalents in its portfolio. We started the year with \$229,350 and withdrew 5%, \$11,537, (2 ½% in the spring and fall) for the Church operating account. We ended the year with \$208,271 in Mutual funds, and \$18,067 in cash totaling \$226,338; a loss of 1.3 %. Had we not taken out the \$11,537 our gain would have been 3.7%

\*The Parsonage Fund\* also has 6 Mutual Funds and about 7.8% cash in its portfolio. We started the year with \$82,726 and after withdrawing \$4,800 for the Church operating account we ended the year with \$77,995; down 5.7 %. Had we not taken out the \$4,800 for the Church operating account we would have broken even.

Summarizing the funds we managed in 2015 we started with \$312,076. We withdrew \$16,337 (for the church operating account) and ended year 2015 with \$307,333; down 1.5 %. Had we not taken out the \$16,337 we would have been **up 3.7**%

To compare our performance, gains for the three major indexes for the year 2015 were

DJIA - 2.2 % Nasdaq + 5.7 % S&P 500 - 0.7 %

At year end we were invested in 12 diversified no load mutual funds. Our holdings are in 5 families of funds consisting of: Fidelity, T. Rowe Price, Vanguard, Nuveen and Dreyfus and include Capitol growth and appreciation funds, new Asia fund, Global equity, high income, mid cap, small capital growth, and real estate funds.
