o Special Education Presentation slide show by Bill. Reviewed history of special education laws, using a variety of education references from popular media. Most recent law is IDEA of 2004. It stated that all children have the right to a free and appropriate public education (FAPE) in the least restrictive environment (LRE). Bill stated that implementation of IDEA has been complicated and expensive. Compliance has been difficult. A new collaborative, represented at our meeting by Jill Graham, is looking at more effective ways of serving our students; they will have a formal proposal for us to consider in November. In the meantime,

Bill is developing a two year plan for the SU that will better serve all students, streamline resources, and help us achieve more compliance.
