In-Person Instruction Monday through Friday: 2021-2022

School will start at 8:10 a.m. with students not being allowed in the building before 7:30 a.m.

School will be in session for a full day with a 2:45 p.m. dismissal for walkers, 2:50 p.m. dismissal for bus students and a 3:00 p.m. dismissal time for car line students.

Every Tuesday will be a 2:00 p.m. dismissal for all students.

Prevention And Mitigation Strategies

Temperature checks at the front door and bus will not be required. Parents and guardians of all students are required to screen their students each day to make sure they have no fever or symptoms associated with infectious illness. If a student has symptoms please keep them home.

The Illinois State Board of Education announced on Friday, August 6 guidance along with Illinois Governor JB Pritzker's mask mandate on Wednesday, August 4, 2021 that all K-12 schools must wear masks indoors regardless of vaccination status for all students, staff and teachers.

Bus students are required to wear a mask at all times while riding the bus.

Social distancing will be enforced. School staff are to help students commit to social distancing as much as possible by: arrangement of furniture, play spaces and classroom materials to model and reinforce physical distancing of at least 3 feet, when possible and practical;

providing assigned seating for students and encourage students to remain in their assigned area; traveling to and from classrooms within the buildings.

Proper cleaning/disinfecting practices will continue to be utilized by the custodial and transportation staff, focusing on "high touch" surfaces just like last year.

Good hand hygiene will be strongly encouraged and modeled. Hand sanitizer will be available in various locations throughout the building.

Hands-free bottle fill water fountains are available throughout the building and will be utilized to reduce contact with "high touch" surfaces. Students will be required to bring a water bottle to school that they can use at the water fountains.

Students will eat breakfast and lunch in the cafeteria per their assigned lunch schedule.

All school meals will be free for all students for the 2021 – 2022 school year.

In order to qualify for book fee waivers households still must fill out and be determined eligible according to the House and Income form.

Academic Impact of Lost Instructional Time

Students will continue to utilize online learning platforms like Seesaw and Google classroom along with their textbooks for in-person learning depending on the grade level.

Pinckneyville District #50 District is equipped with 1 to 1 Chrome tablets for all students and will continue to utilize these devices as part of their in-person instruction.

Chronic absenteeism will be referred to the ROE 30 Truancy Officer along with the Pinckneyville Police Department. Students are expected to attend school daily.

All medical records, physicals, dental exams, and vision exams should be completed for students as indicated by law.

Students diagnosed with COVID-19, with COVID-19 symptoms or who have had close contact with a person infected with COVID-19 must quarantine in accordance with CDC and IDPH guidelines.

Remote Learning: In accordance with the declaration of the Illinois State Board of Education, remote learning is only required to be provided to students who have not received a COVID-19 vaccine or who are not eligible for a COVID-19 vaccine, only while they are under quarantine consistent with guidance or requirements from a local public health department or the Illinois Department of Public Health. Athletic and extracurricular programs including school/community events will resume. Admission will be charged at sporting events. All indoor sports will be covered under the mask mandate. Athletic expectations will follow SIJHSAA guidelines.

Please understand the Pinckneyville District #50 Reopening Plan may be revised and modified as necessary based on school, community, and county positivity numbers and after consultation with local public health officials. Modifications to this plan could include increased mitigation measures to decrease the spread of COVID-19, including but not limited to increasing social distancing and other appropriate mitigation measures. The district will closely monitor COVID-19 cases in the school, county, and surrounding area. If community spread becomes an issue, the district will adjust educational and athletic programming as necessary.

Visitors to the School

Masks are required for all visitors entering the building.

Visitors must self-certify they are free of infectious illness symptoms before entering the building.
