#### COVID

- One classroom went on-line when teacher and assistant both tested COVID positive

  - Moving forward, hoping both adults do not get COVID at the same time.
  - If one adult available, we will not close the classroom.
  - We offer assistants additional pay to run classroom if teacher is out
  - Two substitutes on call as needed
- OHSU testing

  - Parents click link and can drop tests at school or at specified locations
  - Action: Jim will review process for signing up and f/u with Nikki
