3. Board members will make all reasonable effort to attend all Board meetings and work sessions.
4. Neither the Superintendent nor individual Board members will put one another in a position to discuss items or make recommendations in the absence of appropriate information and preparation.
5. During the Public Comment section of Board meetings, Board members will listen respectfully to issues brought to them by the community. Board members may ask questions for clarification from the administration and/or the speaker. The Board will not deliberate or take action during the open forum regarding an issue presented. If public follow-up is required, it will be presented at a subsequent meeting.
6. The Superintendent will make every effort to provide the School Board complete and well-organized materials for meetings and sound rationale for recommendations.
