

## Citizenship Evidence Affidavit

I, (your name here) , agent, being of sound mind and lawful age do solemnly declare:

I am a living man/woman. I reserve all my God given Constitutionally protected rights. I am not a corporation. I do not live or work in the District of Columbia. I am not a “citizen of the United States,” “U.S. person,” or a “resident.” I am only and exclusively a national as per 8 USC 1101(a)(21). Please keep this affidavit permanently in my administrative file and update my records accordingly.

1 Section 1 of the 14th Amendment of the Constitution begins: “All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside.”

2 Section 1 of the 14th Amendment does not say: “All persons born or naturalized in the United States are subject to the jurisdiction thereof...”

3 Section 1 of the 14th Amendment contains two requirements for United States citizenship: (1) that a person be born or naturalized in the United States and (2) that a person be subject to the jurisdiction of the United States.

4 I receive no rights from the 14th Amendment as my rights come from my Creator, God above. Since I get no protection from the 14th Amendment, I have no reciprocal allegiance or obligation. Thus, I am not “subject to the jurisdiction thereof...”

5 The Department of State document, “Certificates of Non-Citizen Nationality,” located at <https://travel.state.gov/content/travel/en/legal/travel-legal-considerations/us-citizenship/Certificates-Non-Citizen-Nationality.html> says in the second paragraph (in part): “As defined by the INA, all U.S. citizens are U.S. nationals...”

Section 101(a)(21) of the INA defines the term “national” as “a person owing permanent allegiance to a state.”

6 I do solemnly swear and declare under penalty of perjury under the laws of the united states of America that I am a national with God-given, Constitutionally-protected Rights, and not a citizen of the United States with civil rights under the scope of the 14th Amendment in condition of voluntary servitude.

7 This affidavit is submitted to legally and lawfully rebut the fraudulent legal presumption that I am a “citizen of the United States” under the scope and purview of the 14th Amendment’s Federal citizenship and that such Federal citizenship grants me “civil rights.”

8 I am a “non-resident” to the “residency” of the 14th Amendment and “alien” to the “federal citizenship” thereof; therefore, I am not subject to the jurisdictional statements of the United States Code.

9 Furthermore, I am not a “resident” of any State under the 14th Amendment.

10 The tax imposed in 26 U.S.C. 1, pursuant to 26 C.F.R. 1.1-1 is on "citizens" and "residents" of the 14th Amendment and is not applicable to me as I am neither a "citizen" or "resident."

11 I hereby publicly disavow any contract, form, agreement, application, certificate, license, permit, or any other document that I or any other person may have signed expressly or by acquiescence that would grant me any privileges and thereby ascribe me rights and duties under a separate system of law other than the Constitutional contract of 1787 for the united states of America and of the constitutions for the several states of the Union, exclusive of the 14th Amendment.

12 I have made the above determinations and declarations with no compulsion other than my own desire.

13 At any time, I reserve the right to amend and correct wherever necessary.

14 I invite any individual who has reason to believe that I am in error in my facts and conclusions above to file an affidavit stating the contrary facts and conclusions signed under penalty of perjury before a notary.

I declare, under penalty of perjury, under the laws of the united states of America that the foregoing is true and correct
