

CP3/MCP3 Recertification Application

The IAP2 USA Professional Program, Policies, and Procedures Manual includes the following section:

Ongoing Requirements and Periodic Recertification

To maintain professional certification, CP3 and MCP3 are required to:

- Maintain active membership in IAP2 USA.
- Provide a minimum of 20 hours (annually) of volunteer (unpaid) service to IAP2 USA.
- Participate in a minimum of 12 hours (annually) of continued professional development.

In addition, every three years, Certified Professionals are required to submit a recertification application for review by two or more assessors. Refer to The IAP2 USA Professional Program, Policies, and Procedures Manual for more information about the recertification process.

The application includes a professional goal for the next three years, a self-assessment related to your progress on the goal established during your prior certification cycle, and a project description for a project completed since you completed the prior certification cycle.

Certified Professionals who are no longer working in the P2 field may request a switch to Emeritus status. They may use the appropriate designation CP3 Emeritus or MCP3 Emeritus indefinitely without meeting requirements for maintaining certification or recertification as long as they maintain membership in IAP2.


