


Colonial connections



how



I was reading Dr. Jane¹ Ohlmeyer, book on Ireland and empire. Following the book and lecture on the British acquisition of Bombay I started looking at my notes on those with a West Cork background who had colonial experience. I was surprised by the number, military, medical, engineering, legal and religious. I had not realised that forfeit Irish Land as well as producing revenue was used to give collateral security to fund slavery and sugar and

tobacco enterprises. It seems that many of the grantees of Irish Land were associated with London networks such as the Thompson family heavily involved in the East India Company. Later in the end of the 17th century they were also probably involved in the Hollow Blade Company, a consortium of London merchants who financed Parliament in its war against the English King and surprise surprise they were repaid in grants of Irish confiscated land. In the same book she described in forensic detail the Irish involvement of both Irish Catholics and Protestants in the slave trade and tobacco and sugar plantations.

Ireland did not have colonies but was in the peculiar position of both being a colony and Irish people both Catholic and Protestant of all classes being complicit in slavery. This was not just with the English but with all colonial powers. Dr. Ohlmeyer cites a number of examples, the Danes had a small colony in the West Indies but no commercial network to sell the sugar from the slave plantations. Apparently their Lutheran religion proved no barriers to using Irish Catholic merchant networks on the Continent to sell their sugar. The Irish Catholic Carroll family had extensive plantation in Maryland and slaves. Charles Carroll² of the family signed the American Declaration of Independence.

Richard Boyle the Great Earl of Cork acquired much of the land granted to Phane Beecher around Bandon. The iron from his works were used to bribe African Chiefs to sell their own people into slavery. The McCalmont family of Co. Derry had extensive plantations in Barbados and multiple slaves. when slavery was abolished³. From the compensation they received they invested in West London real estate and initially leased Mount Juliet in Co. Kilkenny from the Butler family eventually acquired it outright.

The Munster ports⁴ (like Bristol) were heavily involved in the Atlantic 'Triangular Trade' and that was explicitly tied into securing and transporting slaves, and dealing in the products that then came from their work....cotton, indigo, rice, sugar and molasses etc. Of course Munster butter, bacon and beef (the Provisions Trade) partly went to feed those enslaved too. Behind all were the investments, security on loans and profits coming back. The big houses, fine streets, public buildings and squares didn't only come from Irish rents! There is no getting away from widespread complicity.

Though barred from holding office in Maryland because of his religion, Carroll emerged as a leader of the state's movement for independence. The young Carroll was educated at a [Jesuit](#) preparatory school known as Bohemia Manor in [Cecil County](#) on Maryland's [Eastern Shore](#).^[14] At age 11, he was sent to France, where he continued in Jesuit schools, first at the [College of St. Omer](#) in Northern France and later the [Lycée Louis-le-Grand](#) in Paris, graduating in 1755. He continued his studies in Europe and [read law](#) in London before returning to Annapolis in 1765.^{[14][15]}




William Penn⁹ entered Christ Church College, Oxford, in 1660 but was expelled for religious non-conformity in 1662. He then went to France, and in 1663 was studying theology under Moses Amyraut at the protestant academy at Saumur. He returned to London in 1664, and entered Lincoln's Inn in 1665, in which year he was also with the English fleet and at Whitehall. In February 1666 the 21-year-old Penn was dispatched to Ireland to attend to his father's interests in new land settlement then being imposed on the kingdom. The Macroom estates had been restored to the MacCarthys, and the Act of Settlement (1662) compensated Penn with about 7,500 Irish acres, some in the barony of Ibaune and Barryroe in west Co. Cork, and more in the barony of Imokilly in east Co. Cork, with a house at Shanagarry. The young Penn, heir to an Irish estate and intended by his father for the life of a courtier, moved freely among the powerful and wealthy in Ireland.

Penn spent the years 1682–4 in Pennsylvania, establishing its government and disputing its boundaries with governors of neighbouring colonies, including Thomas Dongan (qv) of New York. He intended to return, but a visit to England was prolonged indefinitely by the accession of James II in 1685.



The pilchard business collapsed around¹² 1740 with the disappearance of the fish from the local waters. However Crookhaven became an important point for provisioning ships including the **East India Company fleet**, major centre for provisioning. The requirement for provisioning created a demand for Coopers for pickled meats and saltfish.

Rev. Paul Limrick legal Action c 1725 re Glebe of Crookhaven, In the court case concerning the glebe in Crookhaven, Paul wrote "Crookhaven is eight miles of barbarous road from Skull, and in winter, though I take horse before day, I can scarce reach Crookhaven by 12 o'clock. I am obliged immediately, without refreshing myself, to take horse and ride in the night to get home, for there is not in the whole parish a bed a man can lie on, or a morsel to be eaten..." People mentioned: Rev. Demetrius O'Coghlan, ordained in Cork 1618, fled to England in Rising 1641 and died there, Thadeus Coghlan son to Rev. 

1794 Dr. Dean Mahomet¹⁹ Pioneer Hydrotherapy Stayed for a period with Baker family at Fort William in the vicinity of present Silver Springs Hotel In 1784, at the age of twenty-five, a man named Sake Dean Mahomet sailed into Cork harbour with his patron, Godfrey Evans Baker. He left behind his life in India, (including **fifteen years of service in the East India Company**), and established himself as a respectable and respected man in Cork – later publishing a book, The Travels of Dean Mahomet. His life is a fascinating testament to self-determination, resilience, and sheer inventiveness. According to historian William Dalrymple, Dean Mahomet was “constantly charming and infinitely adaptable, intelligent and sharp witted, part charlatan and part Renaissance man”. the Baker family belonged to the landowning, merchant Protestant Ascendancy of Cork. Under their sponsorship, Dean Mahomet was dispatched to school, where – in addition to acquiring and advanced education in the classics and literature – he met and eloped with a young student, Jane Daly. It's likely she was the daughter of Samuel Daly, a stone mason, as the baptismal register of her son records Felix Daly (merchant) as a sponsor. Prior to publishing his Travels, Dean Mahomet received subscriptions from 320 people, most belonging to the social elite of Munster. His book, written in epistolary style, was a travel narrative about India and he made no mention of his time in Ireland (nor in any subsequent writings). After the death of Godfrey Evans Baker, Dean Mahomet moved to Fortwilliam, the newly-built mansion of the younger brother, William Massey Baker. This house is now known as the Silver Springs Hotel. William had also been in India and returned with considerable wealth and a daughter, Eliza or Eleanor, his lovechild with an Indian mistress.



[1] He entered TCD as a pensioner in November 1801, aged 18, being awarded a BA in 1805. They moved to Castlebar where in 1876 he entered partnership with James Daly and purchased the ailing Castlebar based newspaper The Mayo Telegraph which was renamed the Connaught Telegraph. The Partnership was dissolved in late 1878 due to Alfred's ill health. He died in Dublin in 1879 and his buried in Glasnevin cemetery.

Surgeon Major Dr. Martin Crofts – from Timoleague, after attending Queens University Cork to obtain a medical degree, he joined the Indian Medical Service. **His first ten years in India were with the British Army as medical surgeon for the 10th Bengal Lancers. He was involved in many battles. In 1886, the state of Gwalior was grieving the death of its Maharajah Jayajirao Sindhia, who had made Gwalior the most advanced city in India.** His son and heir, Maharaja Madhav Rao Scindia, was ten years-old. As Gwalior held a strategic position between north and south India, the British considered it one of its most important strongholds in the country. Dr Crofts was appointed residency surgeon of Gwalior and tutor to the new Maharaja Madhav Rao Scindia. Crofts became close with the boy and a great respect developed between the pair. Dr Crofts passed away in 1915 due to heart disease. In the early 1920s, the Maharajah financed the completion of mosaics in memory of his friend. Inside the beautiful Anglican Church of Ascension in Timoleague is an elaborate treasure of Byzantine style mosaics that envelop the walls and chancel. On the south wall, among the Indian flower designs, is inlaid a tribute to Dr Crofts.

On January 22, 1879, under a mountain named Isandlwana, a Zulu force, some 20,000 strong attacked a British military encampment containing about 1,700 men; British regulars, colonial volunteers and native levies, part of a column that had invaded Zululand only twelve days earlier.

The British commander Lord Chelmsford, had committed a series of blunders. The camp had not been fortified, no one was clear who was in command of it and the larger part of the British column, including Chelmsford himself, was out searching for the Zulus in the hills some twelve miles distant from the camp, at the time of the attack.

By the afternoon of the 22nd, all but a few hundred of the camp's garrison were dead, shot, stabbed and in most cases ritually disembowelled too, lying among the wreckage of the encampment. There was no shortage of Irishmen among the British dead. Both of the two commanders of the camp had Irish links. One was Colonel Anthony Durnford, who was born in County Leitrim. The other, Lieutenant Colonel Henry Pulliense's wife Fanny (nee Bell) was from Fermoy in County Cork. Many Irish soldiers died in the Anglo-Zulu War of 1879 but not everyone in Ireland mourned their deaths or accepted the legitimacy of the war itself.

Nevill Coghill, one of two lieutenants who were posthumously awarded the Victoria Cross for attempting, unsuccessfully, to save the regimental colours, was born in Drumcondra in Dublin. He was one of hundreds of men caught attempting to flee the stricken camp on horseback and killed by the pursuing Zulus.

But not everyone in Ireland mourned the British dead of Isandlwana. The nationalist newspaper *The Nation* commented 'Isandula [sic] hath warmed each true man's heart, hurrah for the Zulu king, hurrah for his warriors brave and soon may their shouts of victory ring'.

Michael Davitt, the Land League organiser, told a rally at Gurteen County Sligo that, there was 'great similarity between the Irish pike and Zulu assegai [spear] and English soldiers who went to civilise the Zulus at the point of the bayonet found that the savage African knew how to handle an assegai almost as well as our ancestors knew how to handle a pike in [17]98'. He was indicted for treason for the speech.

At another Land League meeting in County Galway, where the crowd cheered for the Zulu King, Cetshwayo, the speaker, Malachi O'Sullivan told them, 'you do well to cheer for the Zulus. After 700 years you know what it is to live under English rule and you know well what the Zulus will suffer if they are brought under that rule. [2]

He went to Queens College Cork (UCC). He gained his MD in 1889 in TCD. **He joined the Indian Medical Service (IMS) in 1891**, and did army service for two years including the North West Frontier. He retired from the IMS in 1920, aged 57, and settled in Gloucester, England. He frequently visited his sisters in Ummera House in Timoleague, West Cork. They shared his interest in Natural History, and they went on many field trips together. As an expert lepidopterist, studying moths and butterflies, he discovered the haunts of the White Prominent in Kerry, and the existence of Webbs Wainscot in coastal bogs of County Cork.

He died in 1951, aged 88. His obituary in the BMJ speaks movingly of his great expertise in Tropical Medicine, his dedication, humour, humanity and varied interests.

Drumbroe, Mealagh Valley, was owned by the White family from the 1790s until 1853 when Major Arthur Wilkinson bought it. After 1880 Drumbrow Lake was selected for a reservoir; this gave the impetus to Arthur Berkeley Wilkinson to build a series of water gardens, dedicated to the cultivation of water lilies. The gardens also contained a range of wayside flowers supplied from Glasnevin, and in turn Drumbrow supplied Glasnevin with bamboo, water lily, phlox and butterwort. After Wilkinson's death the estate was neglected and the water garden fell into disrepair. **Arthur⁸⁶ senior served in India and on the Afghan border before retiring to purchase Drumbroe which was part of Simon White's lands.** He served as a justice of the Peace⁸⁷ but while Arthur junior and the mother are buried in the Abbey we found no trace of where Arthur Senior was buried but I think I came across he was born in Doneraile. Drumbrow lake now supplies some of the Bantry water supply however plans to flood the areas near the lake including the old estate lands was stopped because of the gardens perceived importance

His parents were William Telford Dennison and Mary Hester Coulter. He was the grandson of Patrick and Jane Spence. Patrick was a merchant in Manorhamilton. After the war he became a **Judge and served in a number of African countries**. He was awarded an OBE by Queen Elizabeth for his work. He returned home in 1967 and worked with Fermanagh council. He died on the 12th January 1992. He was captured in September 1944 near Arnheim after being wounded but managed to escape while being transferred to a different POW camp. He rejoined his regiment and served out the remainder of the war.
