BOARDING AGREEMENT – EMERGENCY MEDICAL RELEASE – CARE AND SAFETY

_ If, in our judgment, your animal requires immediate medical care and we are unable to reach you, we will take your animal to a veterinarian. Tatjana's Pet Sitting will make every attempt to contact the primary owner or emergency contact in a case of emergency prior to any medical care.

_ By signing this agreement, you agree to be solely responsible for the payment of all medical bills for your animal, and you release Tatjana's Pet Sitting, its officers, directors, agents, volunteers, and employees of and from any and all responsibility for, or claims, damages, debts, arising out of or related to such medical care, including, but not limited to, transportation to/from the veterinary clinic and choice of veterinarian and animal hospital, transportation to/from Tatjana's Pet Sitting to your home.

_ Tatjana's Pet Sitting reserves the right to immediately change your animal's type of boarding/crate or if we believe it is necessary to protect the health and wellbeing of your animal (example. illness/nausea/anxiety/flea infestation).

_ If your animal is exhibiting any symptoms that may suggest illness such as sneezing-coughing-wheezing with runny eyes and/or a nose discharge, contagious sinus infection, vomiting, lethargy, or diarrhea, please do not bring your animal to boarding. Please discuss allergies that your animal suffers from prior to boarding.

_ If your animal comes into heat while being boarded your animal will be kept separate from others and Tatjana's Pet Sitting cannot be held liable if your animal is not spayed or neutered. Specify if in-heat/not spayed/intact.

_ Animals with flea or tick problems will be treated with a flea tablet or flea/tick treatment, at the owner's expense (\$8/day for Capstar) after a phone call to the owner. Animals with flea or parasite infestation will be removed from the boarding area and will be picked up by the owner immediately. Such an animal will be kept in a separate quarantine area until the pickup.

_ I acknowledge and understand that there are certain risks involved in boarding, including but not limited to animal fights, animal bites to humans or other animals, and the transmission of disease. Any medical expenses will be my responsibility and I release Tatjana's Pet Sitting of any charges.

_ All charges must be paid upon pick-up of your animal. Animals left ten (10) days beyond the agreed pick-up date with no response from the owner or emergency contact (or payment) will become property of Tatjana's Pet Sitting and may be adopted out to the local Animal Shelter unless we have another agreement in place. Verbal agreements are to be noted down.

_ I agree not to enter the premises of Tatjana's Pet Sitting when dropping off or picking up my animal unless I have a scheduled appointment to do so, and only in a case of emergency. Tatjana's Pet Sitting has certain management practices in place to prevent the introduction of new diseases or bacteria, especially K-9 influenza and the new respiratory virus. No visitors are allowed to prevent accidental introduction of organisms that are harmful to boarding animals. Tatjana's Pet Sitting premises and boarding areas are disinfected daily. Please keep your water/food bowls at home unless absolutely necessary.

_ Tatjana's Pet Sitting reserves the right to immediately change your animal's type of diet or if we believe it is necessary to protect the health and wellbeing of your animal. The diet may include only rice, fibrous vegetables and meat (chicken or beef) with exclusion of dog food on any sign of diarrhea/upset stomach. Vegetable (steamed): Broccoli, carrots, pumpkin puree. No raw foods allowed/offered unless provided by the owner with specific instructions.

_ I understand that Tatjana's Pet Sitting obeys the Dog Leash Law for safety and protection and reserves the right to use her leashes and collars.

Food/Toys: Our house brand of animal food is Purina. Changing animal food can cause an upset stomach, owners are expected to and encouraged to bring their animal's food and treats from home. Owners are welcome to bring their small CLEAN bedding, kitty litter and toys, however we cannot guarantee that they will be returned in the same condition. Dirty bedding will not be allowed inside and will be replaced with Tatjana's Pet Sitting bedding (waterproof dog pads, beds or soft blankets).

PAYMENT FORM: Make payments to Tatjana Thomas. We accept Venmo/Paypal/ApplePay/CashApp, 3% fees might apply. Cash/check also accepted. Total payment is due upon pickup of your animal. Tatjana's Pet Sitting reserves the right, without notice, to adjust its fees for services. Please inquire with Tatjana Thomas to discuss your current fees. Digital/paper receipts will be provided per request.

Animals without copies of Distemper/Rabies will not be accepted. No distemper? Please provide a medical necessity letter from the veterinarian stating a medical reason for no distemper/rabies vaccination.

Animals with expired records will not be boarded.

By signing the Boarding Agreement, you agree to the terms and conditions of this agreement.

I certify the information I provided in connection with this form is true and correct to the best of my knowledge. I also understand that any false statements or deliberate omissions on this form may subject me to legal actions.

By submitting these forms you the owner listed below indicate your agreement with all the terms listed hereof,

You release, indemnify, and agree to hold Tatjana's Pet Sitting harmless from any and all manner of damages, claims, loss, liabilities, costs or expenses, causes of actions or suits, whatsoever in law or equity, (including, without limitation, attorney's fees and related costs) arising out of or related to the services provided by Tatjana Thomas, except which may arise from the sole gross negligence or intentional and willful misconduct of Tatjana's Pet Sitting including, without limitation, any inaccuracy in any statement made by yourself or information provided by you to Tatjana's Pet Sitting, your animal, including but not limited to destruction of property, animal bites, injury, and transmission of disease, and any action by yourself which is in breach of the terms and conditions of this agreement.

This agreement covers the current relationship between Tatjana's Pet Sitting and yourself. Each time you bring your animal, dog or cat, to Tatjana's Pet Sitting, you affirm the terms of this Boarding Agreement and Emergency Medical Release, and the truthfulness and accuracy of all statements you make in this Agreement.

X The IL State Law requires consent from the animal owners for the following; The owner agrees to let the animal co-house (board) with another animal under one roof (meaning Tatjana's Pet Sitting house). Expl. Your animal will co-house under one roof, with other animals. Your pet will be kept separate from other animals unless they are of the same human family. Family dogs are kept/fed together, or separate - at the owner's request.
