[XINGYUAN TECHNOLOGY PTE.LTD.](“we” or “us”) are committed to protecting your privacy. We know that we have a responsibility to protect the privacy of your information and our goal is to earn your trust through the privacy decisions we make each day.

We provide you with clear and transparent Privacy Policy (“Policy”) about the information we collect and how we use it when you use the [Super Cleaner: Clean Storage] (“app”) or when we provide you with services. And, unless the data we collect is necessary to deliver and maintain the best services and experiences with us, we provide you with choices about how we use your information.

What information do we collect?

We collect information when you interact with us and use this app and our services, we also obtain information from others.

The types of information we, or service providers acting on our behalf, collect may include the information about:

Contact information, such as your name, mobile phone number and email address.
How you use our app and your devices, such as (1) behavioral usage of the app; (2) the type, brand, and language of handset device;(3) mobile operating system; (4) the type and operator of network;(5) device identifiers (such as IDFA, IDFV, GAID);
Location of your wireless devices, such as (1) the type of your internet (such as Wi-Fi, 4g, 5g); (2) mac address.

How do we use information?

We use information to:

- Deliver and maintain the app and services;
- Provide you with our services;
- Help you with service and technical support issues or questions;
- Manage and protect our networks, services, employees and users;
- Detect and prevent fraud;
- Help us improve and personalize your services and our marketing;
- Research, develop and market new products and services;
- Better predict and deliver personalized content and offers that may interest you.

Do we share your information?

We share information with our affiliates, for a variety of purposes, including providing you with the latest information about our products and services.

We use service providers to help us offer, provide, repair and restore for services. We share information with them as necessary for them to perform work for us. They are required to protect information they receive from us or collect on our behalf and use it only for the purposes we allow.

In certain circumstances, we disclose your information in order to comply with the law, to protect you, others or us or with your consent.

How do we protect and retain your information?

We use technical, administrative and physical safeguards to help protect against unauthorized access to, use or disclosure of information we collect or store. In addition, we train our employees on the importance of privacy and security, as well as the proper ways to access, use and disclose your information. Our practices and policies prohibit employees with whom we share this information from using sensitive information unless they are authorized to do so and have a business need.

Although we strive to keep information secure, we can't guarantee that our safeguards will prevent every unauthorized attempt to access, use or disclose personal information.

Our policies require that we retain records for as long as they are needed for legal, tax, audit, investigative, and security purposes and then securely delete or destroy them.

What rights do you have under privacy laws?

The privacy laws provide you with specific rights:

You have the right to know what personal information we collect, how we use it, and how long we keep it.

You have the right to access, delete, update and correct information.

You have the right to ask us to provide your personal information to you in a structured, commonly used, machine-readable format.

You have the right to withdraw your consent where processing is based on a consent you have previously provided. Your withdrawal of consent will not affect the lawfulness of the processing done prior to your withdrawal of consent taking effect.

To exercise your rights, please contact us. In order to properly process a request, we may need to verify your identity before taking any request-related actions. If needed, we will contact you via email with reasonable instructions to verify your identity before processing your request.

How do we protect children's personal information?

This app is not directed toward children under 13 and we do not knowingly collect personal information from minors. If you are under 13, please do not use the app or share personal information with us. If you learn that anyone younger than 13 has unlawfully provided us personal information, please contact us.
