PRIVACY POLICY

This page informs you of our policies regarding the collection, use, and disclosure of personal data when you use our Service and the choices you have associated with that data.

We use your data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this policy. Personal Information Provided by You

If you are a Candidate or an employee accessing our services, we may collect Names; E-mail addresses; mailing addresses; Job titles; Educational qualifications; Professional qualifications; personal preferences; usernames; passwords; contact preferences; Contact or authentication data; and other similar information. Payment Data

We may collect data necessary to process your payment if you make purchases such as your payment instrument number (Such as credit card number, and the security code associated with your payment instrument.

Social Media Login Data

Usage Data
