

DHHS90858 RATE TABLE

Payment to the Contractor will be based on the rates specified in the Rate Table below.

1. The April 1, 2022 rate increases reflected in the Rate Table below were awarded pursuant to the FY22 General Session, Senate Bill 3 (collectively “S.B.3”). The Contractor must use the increase from S.B.3 for the sole purpose of increasing the salary and benefits of all Contractor staff positions that spend 50% or more of their time providing direct care to Persons (direct care staff positions). No portion of the increase may be allocated to administrative functions, provider profit, or retained earnings. The Contractor must report back to DSPD on its use of these rate increases by providing information in the format and within the time frame requested by DSPD. In the event any portion of the S.B.3 rate increases are used for any purpose other than increasing the salary and benefits of the Contractor’s direct care staff positions, the Contractor will be required to reimburse DSPD for that portion in accordance with the remedies stated in the contract.

2. The 3.65 % rate increases effective July 1, 2022 and reflected in the Rate Table below, were awarded pursuant to the 2022 general legislative session. This rate increase replaces the quarterly supplemental payments received for the last year and half via American Rescue Plan Act (ARPA) funding. The purpose of this increase is to expand, enhance, and improve Home and Community Based Services (HCBS).

3. Effective January 1, 2023 rates are increased 2.53%. The Limited Supports Waiver has a 2% annual rate increase. The additional .53% increase is to bring the rates up to the intended 4.18% awarded pursuant to the 2022 general legislative session to replace the supplemental payments received via ARPA. The 3.65% rate increase that was effective July 1, 2022 and the .53% effective January 1, 2023 is for the purpose to expand, enhance, and improve HCBS.

4. Effective January 1, 2024, rates are increased 2% as a result of the Limited Supports Waiver having an annual 2% rate increase.

5. Effective January 1, 2025, rate are increased 2% as a result of the Limited Supports Waiver having an annual 2% increase.
