

Installation/Alterations Of Security Systems

1. GENERAL

Acceptance of any installation contract offered by the company to the customer for a new and/or part replacement of a security system is subject to these Terms and Conditions along with any other requirements defined within the Specification. For the purposes of interpretation, where the requirements of the Specification conflict with any clauses of these Terms and Conditions, conditions of these terms and conditions including any system requirements shall take precedence. All other terms and conditions not contained in or implied by the Contract are excluded. Nothing in these Terms and Conditions, stated or implied, shall detract from the Customer's statutory rights.

2. COSTS

- i) The quoted costs may be revised if:
 - a) you want the work carried out more urgently than agreed, or
 - b) you change the Specification, or
 - c) your Premises are in some way unsuitable for the equipment and this was not apparent from our original survey or there are circumstances about which we should have been made aware, or
 - d) there are any other special circumstances we were not aware of when supplying our original quotation.
- ii) All ethernet line installation and rental are the responsibility of the Customer.
- iii)You agree to take reasonable care and ensure the Equipment on our behalf until you have paid for it in full.
- iv) If our labor or material costs increase after twelve months, we may give you two months' notice of any increase in our annual maintenance charges.
- v) Installation work is normally carried out during usual working hours of 9:00 am to 5:00 pm Monday to Friday except statutory holidays. Requests made by the Customer to install outside these hours may incur additional charges. See 2(i) above.

vi) Unless otherwise agreed in writing, the Quotation does not include additional work such as redecoration, carpet laying or building work, although we will take all reasonable care of your premises. Additional charges may be made if our technicians are not provided with access to doors, shutters, windows or any other areas where cables and equipment needs to be maintained, inspected or replaced.

3. COMPANY'S OBLIGATIONS

- i) We agree to install a new security system or partial new upgrade of an existing security system in accordance with our specification and quotation.
- ii) When we issue new certification after an installation visit, this shall last for a maximum period of that stated in the expiry date. Where Certificate of Conformities is issued the certificate shall remain the property of the company until the contract has been paid for in full.
- iii) We agree that, if any of the Equipment or our workmanship is faulty in the first twelve months, it will be repaired or replaced at our expense, including call-out, provided you let us know as soon as the fault occurs.
- iv) We agree to take all reasonable measures to protect the customer from a cyber or internet-based security attack. The company cannot guarantee that any such attack would not be successful.
- v) We agree to carry out the installation at the customers premises in normal business working hours, from 9:00 am-5:00 pm Mon-Fri excluding bank holidays. (Unless otherwise agreed in writing)

4. **CUSTOMER'S OBLIGATIONS**

- a) You agree to give us and our workers full access to your Premises to survey, measure, install, test and install the Equipment. You also agree to provide an adequate electricity supply for the Equipment to operate correctly. If our work is interrupted or delayed because of a problem with access, or the electricity supply is inadequate, we may make an extra charge. We are not liable if completion of the installation of the system upon our visit is delayed due to the unavailability of signaling transmission facilities or other circumstances beyond our control. By signing the Contract with us, you guarantee that you have full authority to allow the installation visit to take place and no other consent is needed.
- b) You must not interfere with, or allow anyone else to interfere with, adjust, service or attempt to repair or reset the Equipment at any time.

- c) If the Equipment activates to an Alarm Receiving Center or Central Monitoring Station, you need to let us know as soon as possible. If the Equipment needs to be reset, we may charge you at our usual rates then in force.
- d) You will need to let us know in advance if any third party intends to carry out work on the communication lines within your premises, as this may affect the Equipment's effectiveness.
- e) The Equipment installed on a new or part upgrade installation visit; where it has been authorized by the customer does not belong to you until it has been paid for in full. If you do not pay the balance of the installation charge when it is due, we have the right to remove the Parts/Equipment from your Premises without notice. By placing an order with us, you irrevocably authorize us to enter your Premises to remove the Equipment if payment remains outstanding.
- f) If you cancel our Contract less than four days before the installation work takes place, we may charge you for any equipment we have bought for your Premises and make a reasonable charge for damages for breach of contract
- g) If the Equipment is connected to an Alarm Receiving Center or Central Monitoring Station, it is your responsibility to make sure that the communication line is working properly and the account correctly maintained. We reserve the right to suspend or terminate monitoring services where payment has not been received, or where the customer is failing to meet obligations upon them.
- h) You need to notify us of any change in the layout of your Premises, as this may affect the effectiveness of the Equipment to detect movement or intrusion within 7 (seven) days of the change taking place.
- i) You agree to permit the Company's staff and representatives of its regulatory body (only whilst accompanied by the Company's staff) access to the installation for the purposes of maintenance or inspection.
- j) Civil works including the supply and installation of ducting, concrete bases, and erecting of structures including automatic gates and CCTV towers must be complete prior to the commencement of installation works by the company. In the event the company attends the customer's premises and the works under the supply of the customer have not been completed, at the sole discretion of the company we reserve the right to charge for the visit due to abortive costs being incurred.
- k) The company assumes that access into new and existing cable draw pit chambers is readily available and chamber lids can be removed easily without specialist equipment. Where this is found not to be the case, the company reserves the right to apply additional charges to the customer.
- I) The customer agrees that any specialist training requirements required to fulfil the obligations of the company will be notified to the company in writing prior to the issue of a quotation.
- m) Where the company provides the customer with a partial upgrade or partial replacement of an existing security system, the company accepts no liability for the existing part of the system,

and no warranty or liability shall be placed upon the company for any equipment not installed by the company.

- n) Statutory safety legislation applies to some products supplied by the company. The customer shall not make any changes of any kind to this equipment without written authority from the company.
- o) Unless where specifically stated otherwise, the company accepts no responsibility for electrical testing or electrical safety inspections. The customer shall employ a third party where such tests are required.
- p) Upon takeover of an existing security system which was installed by a third party, the company accepts no liability for the installation, or its failure to perform. Any such liability will remain with the original installer or the customer.
- q) Design responsibility for a security system is only accepted by the company were indicated within our specification and quotation. Where the company takes over security systems from a third party, no design responsibility is accepted by the company working on behalf of the customer.]
- r) Where the company carries out an inspection or provides certification to the customer, liability shall end immediately after our inspection. Certificates are valid for the period stated, liability ends on the day of inspection. The company accepts no responsibility after the inspection was carried out, due to external influences beyond our control affecting performance and safety once our technicians leave the premises.
- s) The customer shall purchase any remaining parts or material items, where a frame work agreement to purchase an agreed number of items has not been totally fulfilled by the customer by placing adequate orders upon the company, and where the company has no other ready use for such materials.
- t) The customer agrees that the company will reserve the right not to attend the customer's premises where a suitable response contract is not in place, or where the request does not meet the contracted terms of the contract.
- u) The customer shall supply the company all necessary drawings, site plans, service layouts and utility location plans prior to installation work taking place, this will minimize and reduce the risk of any such services being accidentally damaged by the company.

5. LIABILITY

The Company does not know, and shall not be deemed to know, the true value of the Customer's property or premises and is not the insurer thereof. The installation agreements do not constitute a means of insurance to the customer. The customer must make adequate third-party arrangements with a suitable insurance provider to maintain such cover. Such cover must apply to both the customer's property and contents. The company accepts no liability to third parties including but not limited to

insurers and underwriters where the customer has failed to notify the company in writing of any conditions which may apply to their third-party agreements or policies. We do not guarantee to the customer that:

- a) Particular losses or injuries will be prevented by using our security systems or;
- b) That the system will work continuously and without errors in particular when a failure is beyond our reasonable control, for example equipment which may be of old age or prone to the ingress of water due to its design.
- c) If our customer makes incorrect adjustments to any equipment supplied or maintained by On-Off Electronics, no Liability will be accepted by the company.
 - i) The Company shall not be liable for the costs of any work, repairs or replacement of Equipment which results from fire, electrical power surge, storm, flood, accident, neglect, misuse or malicious damage.
 - ii) The Company has provided limited insurance cover for itself with indemnity for claims made against it in respect of loss or damage. Cover also extends to failure to perform and wrongful advice given unwittingly. A copy of the relevant insurance schedule is available to the Customer upon request.
 - iii) Although the Installation is designed to detect or deter intrusion and reduce the risk of loss or damage, the Company does not represent or warrant that the installation may not be neutralized, circumvented or otherwise rendered ineffective by unauthorized persons and in such event the Company shall not be liable for any loss or damage suffered by the Customer or other unauthorized persons. The Company accepts no liability for claims falling outside the ambit of the indemnity referred to in Clause 7 (ii) above and the Customer is advised to arrange sufficient insurance cover in respect of claims arising due to injury, loss or damage howsoever caused.
 - iv) Like all electronic equipment, the system could fail in rare and exceptional circumstances and the Company cannot guarantee that it will be operational at any specific time or for any specific period. The Company will explain what regular tests can be performed to verify that detection equipment is operational between routine maintenance visits carried out by the Company.
 - v) Where the company takes over an existing security system which was installed or maintained by others, we assume the system and any wiring associated to it is in full working order. The Company has no knowledge of such systems and the customer must therefore notify the company in writing of any defects which occur on the system. The company can accept no liability for such systems as we have no knowledge of the customers system or the quality of workmanship including work standards to which it was originally installed.
 - vi) Where the customer fails to act upon remedial work identified by the company which is of a mandatory requirement; such as but not limited to health and safety legislation,

moving machine directives, or any work which may pose a liability to the customer, no liability will be accepted by the company.

vii) The company accepts no liability where the customer fails to notify in writing prior to contract commencement any conditions or arrangements it has with third parties. These include but are not limited to; Insurers, or Underwriters. This includes any specifications; essential coverage plans, response times, or key performance requirements which must met by the company on behalf of the customer; as a condition of the third-party agreement between the customer and that third party.

6. TERMINATION

- i) Either the Customer or the Company can terminate the Contract by giving not less than one weeks' written notice except where a fixed term contract applies. Where the customer wishes to terminate a fixed term contract before its expiry period, any remaining duration must be paid for in full and early termination costs shall apply.
- ii) The Company may terminate this Contract should the Customer breach any of its conditions or if the Customer is in arrears with any payments due for a period in excess of 30 days. This will not prejudice the Company's right to reclaim the payment outstanding.
- iii) In the event that the maintenance contract is terminated, the Company shall be provided with access to recover any equipment and/or firmware which did not belong to the Customer but was rented from the Company.
- iv) The Company reserves the right to remove logos, name plates, motifs or any other Company identity from the Equipment.
- v) The company reserves the right to cancel any order placed by the customer, without incurring any liability.

7. FORCE MAJEURE

Any failure by the Company to fulfil any of its obligations under the terms of this Contract due to reasons beyond its control shall not be considered a breach of this Contract.

8. ACCEPTANCE BY CUSTOMER

The customer undertakes and agrees to accept all of the terms and conditions stated within this document IN FULL upon once placing an order upon the company.

9. RIGHT TO AMMEND, UPDATE OR CHANGE

The company reserves the right to amend, update or change the terms and conditions as defined above, with 30 days written notice to the customer.
