

Terms of use

These Terms of use (the “Terms”) govern your use of all available Barbara Foster Services and Apps, so please read them carefully before using Headphone, Speaker Connect App.

By using Headphone, Speaker Connect App, you agree to be bound by these Terms. If you don't agree to these Terms, do not use Headphone, Speaker Connect App. If you are using Headphone, Speaker Connect App on behalf of an organization (such as your employer), you are agreeing to these Terms for that organization, and are indicating that you have the authority to bind that organization to these Terms. In that case, “you” and “your” will refer to that organization.

We may revise the Terms from time to time. Changes may be posted within our Apps, so please check that regularly.

Auto Renewing Subscriptions

Subscription Services

Headphone, Speaker Connect App on the Apple App Store will allow you to obtain the benefit of the application on a subscription basis. Payment for such a subscription (which may be for example daily, weekly, monthly or yearly) may be processed in the application, by third parties who act on our behalf or directly by the mobile platform owner (Apple). Free trial subscriptions may be canceled at any point up to 24 hours before the expiry of the free trial. You can cancel a subscription service at any time during the subscription period via the subscription settings in your iTunes account. The cancellation will take effect after the last day in the relevant subscription period. You can find further information on canceling orders and any associated refunds on the website of the third party re-seller from whom you purchased the app (the Apple App Store).

Trial Periods

Certain of our subscription services on the Apple App Store may from time to time be offered for a fixed period of time on a free-trial basis. You are free to cancel a free-trial subscription at any time via the subscription setting in your iTunes account.

Your Information and Responsibilities

To use Headphone, Speaker Connect App, you optionally can create an account, either via Headphone, Speaker Connect App or through your account with a third-party service such as Google or Apple. In the latter case, your Headphone, Speaker Connect App account will be created using the information you provided to that service, such as your name and email address and other personal information that your privacy settings on that service permit us to access.

You may use Headphone, Speaker Connect App only if you are 13 years or older and are not barred from using Headphone, Speaker Connect App under applicable law.

You are responsible for safeguarding the password that you use to access Headphone, Speaker Connect App. You are responsible for any activity on your account, whether or not you authorized that activity. You should immediately notify Barbara Foster of any unauthorized use of your account.

By using Headphone, Speaker Connect App, you provide us with text, graphics, images and other information ("your content"). You retain full ownership of your content. Barbara Foster does not claim any ownership rights to your content. However, you are also solely responsible for your content. You indicate that you own or have the necessary rights to all of your content, and that use of your content does not infringe, misappropriate or violate a third party's intellectual property rights, or rights of publicity or privacy, or result in the violation of any applicable law or regulation.

Barbara Foster Intellectual Property Rights
