If the puppy is sold with full registration, it means there are no restrictions on this pup.

The Purchaser agrees that this dog will never be sold to a pet store, to a broker or puppy mill. It will not be sold to another breeder unless discussed with the seller.

Consent must be in writing from the Seller. There will be no Merle to Merle breeding. If you get excessive white, they will be given away as pets and never sold.

Puppy Contract

1. Seller agrees to provide shot and worming records for the puppy.
2. Seller guarantees the puppy to be in good physical and mental condition and to be free from **disease at the time of sale**. Purchaser agrees that the puppy will be examined by their veterinarian **within seven days following the possession by purchaser**. The puppy will be fed by the food provided by the seller for the first few days, then slowly transitioned to a quality food or any problems resulting from poor diet will void this contract. Any sign of illness found within the first 7 days must **immediately** be brought to the Seller's attention. Please understand that worms, diarrhea from change in diet, change in environment or travel stress, etc. can be expected in a new puppy.
3. Seller guarantees the puppy is free from genetic defects detrimental to the puppy's health for up to **one year after birth**. **No other guarantee is offered or implied**. In the event a genetic defect is found by a licensed veterinarian within the 1 year period, a puppy of equal value and sex will be offered as replacement, upon the receipt of letters confirming diagnosis by **TWO** licensed veterinarians, and the return of the puppy at the buyers expense. If no puppy is available at the time, the buyer will have first pick behind the breeder and any prior deposits already in place.
4. **All** vet bills are the responsibility of the Buyer.
5. Seller does not guarantee that the eye color of the puppy will stay the same.
6. Breeding Rights are **NOT** transferable.
7. **Under no circumstances** is the puppy to be sold, leased, or given away to a pet store, lab, research facility, or animal shelter.
8. This contract is non-transferable. Should the Purchaser relinquish ownership of the puppy for any reason, this contract shall be null and void.
9. **If at any time in the life of the dog the Purchaser is unable to keep the dog, Purchaser is to contact the Seller to discuss finding the dog a new home. Seller will either take back the puppy/dog or assist Purchaser in finding a new home.**
