# **Privacy Policy**

This Privacy Policy explains our practices regarding the collection, use, disclosure, and protection of information that is collected through our Service, as well as your choices regarding the collection and use of information.

The app is created to monitor Online status of your kids. This app can help you monitor activities of your kids and get instant notifications about their online and offline statuses. This app doesn't violate the Privacy Policy and Terms of Service of any third parties and use only publicly available data. The app is not affiliated with any 3rd parties.

#### • How We Collect and Use Information

We collect the following types of information about you:

**Registration and Profile Data.** We are responsible for processing your Registration Data, which is used for communications with you and for the provision and management of your use of our Services. It is also used to measure and improve the Services and functionality and to provide customer service, send email notifications and (unless no longer in the distribution list) newsletters, or communications, in general, about the Services, products and novelties, and offers or promotions offered by us.

When you create an account, we may collect your personal information such as your name, mobile phone number and profile photo. If you want to add a contact to your account to see Online status, we collect the contact name and mobile phone number (determined by you).

#### • Data the application receives and stores

- Name and version of the operating system
- Token that allows you to send you notifications.
- Unique user ID (UUID or identifierForVendor).
- Device name
- Application Version
- Language
- A country
- IP address
- Device Model
- The information you enter to use the features of the application.

Commercial Communications. By filling in and sending your Registration Data to us, you expressly consent to receive electronic commercial communications regarding the subject matter of the Services, and other services including alerts and notices about your Covered Account(s), and, if you selected the "opt-in" mechanism, you may also receive newsletters, offers and promotions.

## • Sharing of Your Information

We treat your Data with strict confidentiality in accordance with applicable law. User data is private and never transferred to third parties. For correct operation, the application interacts with social networks. You will see this when you start using the functions of the application. We do not share your data with social networks. What data can be obtained:

# • How do we use your personal data?

We may use your personal data:

- 1. to enable you to access and use the Services. For example;
