# **Legal Concerns**

- Transitioning from government courts & law, to hired justice systems

  How does a liberty-for-real society transition from the currently installed government court system to a poly-legal system?
- When someone claims a NAP violation, but it isn't Is there a better, more workable definition of NAP violations that can withstand all the edge cases?
- Restorative justice processes

  How to return someone to whole when whole is not possible?
- Reputation is not enough: Handling bad actors in liberty societies

  When someone is a bad actor, how can a poly-legal, multi-covenant set of communities protect itself?

#### **Conflicting Segments**

• Handling multiple moral cultures within one libertarian society

Authoritarians fight over who will grab the reins of power to force their values on all.

How can a liberty-for-real society allow multiple value systems (e.g., conservative family vs. libertine prostitution) to live side-by-side?

• Left v. Right in a liberty society

Is the left v. right divide still true w/i a liberty-for-real society? How to allow libertines and Puritans live side-by-side?

• Is Thinness Viable?

One idea of libertarianism is that it can tolerate all values as long as aggression is not initiated. However, is this accurate? Advocates of Hoppe suggest only conservative values are viable? Can hyper-tolerance exist in a liberty-for-real society?

- How much thickness can libertarian society suffer and still be successful
- Is thickness necessary for a liberty society?
- Strange bedfellows: Racists, fascists, communists, misogynists, in a liberty society

Just how far out there is "too far"? And how can such edge cases co-exist peacefully?

#### • Communes vs. Communism

Are left ideologies so intolerant as to always demand to impose on all other communities, and thus are inherently contradictory to a liberty-for-real society?

# **Minority Rights**

• Protecting various groups from vestigal authoritarianism

Lots of people claim libertarianism, but many times they extend tolerance only to "people like us". How can small minority out-groups be sufficiently protected w/i a liberty-for-real society?

#### **Communications**

Conflicting Messages to Conflicting Groups

Liberty-for-Real societies seek liberty people, but not all liberty segments are the same. Messaging to different segments can conflict. In a distributed communication will different messages to different publics that normally would disagree. How can one group's message be sent to its segemnt without scaring off the other other group

# • Politics or Community: Which is more important for attracting migration

Politicos believe a political wins advance liberty the fastest. Community builders believe community builds liberty-community the fastest. What are the conflicts these groups face.

#### Centralization v. Decentralization

To what degree should the development of the liberty-for-real society be controlled by a central body, vs. decentralized out to grassroots.

### • Whom to Seek first for your liberty society?

Not all liberty-for-real society members are equally valuable. Who helps and who detracts?

#### • Personality Differences: Early Versus Later Movers

A liberty movement early on disproportionately attracts personality quirks (e.g., oppositional defiance). Over time, more normies join. How to overcome the bad rep of the initial wave?

Attracting businesses to your liberty-for-real society

Employment is one of a key drive. How can liberty-for-real societies attract businesses that are consonant with liberty?

#### **Constitutions**

- Constitutional and other protections of human rights for liberty society
- Creating a societal framework where human rights will not be so easily violated again.

What type of constitution, or replacement of a constitution, becomes the founding document of a liberty-for-real society?

### Governance

- Democracy in a libertarian society the greatest threat

  How to move from universal democracy across theoretically almost any decision, to
  private decisions of covenant communities.
- Preventing the Emergence of Tyrants
- What must be done centrally?

#### Ostracization/Banishment

• Removing authoritarians from an emerging liberty-for-real society

No matter where one sets up, there is usually an authoritarian base population already
there, and not aligned to liberty. What recourse does a liberty-for-real society have if it
subscribes to the NAP?

- At what point is a citizen of a liberty-for-real society expelled?

  Is there a mechanism to expel a citizen, especially if there are multiple communities.
- Shunning and ostracization v. kindness and redemption

  How do different communities make this tradeoff, and manage the border between these different levels of tolerance?
- Adopting a centralized "social credit score" system to a multi-community network
   "Social credit score" are the bugaboo of authoritarian dystopian societies, but how could
   word of mouth be utilized through technology such that other communities can be
   forewarned about bad-actors, and citizens incorrectly accused of bad acting can quickly
   restore their reputation?

# Money

- Increasing the diffusion of crypto within a liberty-for-real society

  Using crypto requires businesses to accept crypto, but suppliers accepting crypto
  requires lots customers interested in using crypto. How do we get past this chicken &
  egg problem?
- Securing bulk precious metals
   A society that starts using silver and gold will have issues of protecting and transporting heavy and valuable metals.
- Money w/o a Central Bank?
   How can banks start up w/i a liberty-for-real society that circumvent Federal laws on surveillance and fiat?

#### Children

• Child Protection in a multi-moral society

Given a liberty-for-real society will have different relationships between the parent, the child, and the covenant community, to what extent can "child protection" protect children and what would that mean?

- Protecting children in a multi-moral society

  "Child Abuse" is defined differently by different segments. How are children "protected" from abuse and from factional preferences?
- What happens when your child grows up an authoritarian We have had only a few examples of first generation libertarians,

But often we do see libertarian parents raising authoritarian children. What happens to these children within a liberty society
