

During the <u>endorsement process</u>, our endorsement committee got to know the candidates who sought our endorsement through questionnaire responses and in-person interviews. Here are the endorsement committee's impressions of the candidates.

# Whatcom County Council At-Large Position B Endorsed: Carol Frazey

- Carol impressed us by demonstrating a developed understanding of the issues of primary concern to the Riveters' platform, despite the fact that she is a relatively new candidate. Carol is clearly committed to putting in the research work necessary to really understand the issues facing our county.
- Carol relied on demonstrating her ability rather than talking about her ability, and it came through loud and clear.
- Carol is eager and ready to serve the people of Whatcom County. She showed an energy that was lacking in interviews with some candidates for other positions.
- Carol doesn't seem afraid to talk to anyone. We believe Carol when she says she plans to seek out all serious perspectives on all important issues.
- Carol struck us as perhaps the strongest candidate of all those we interviewed on her ideas of how to improve community engagement. She described a plan to develop community liaisons with local constituencies and advocacy groups, to sit down and actively co-create policy with her constituencies, and tomake use of existing county service structures. As Carol has developed her campaign, she has done her due diligence, including meeting with the Sheriff, County Executive, County Financial Manager, and at least 3 current County Council members to learn about the position and develop relationships.
- And, memorably, she asked us how we will want to be engaged once she is elected.
- Carol was clear that she sees her district as Whatcom County, not Bellingham. She plans to represent everyone.

### **Aaron Thomas:**

 We were very impressed with Aaron's desire to seek out voters where they live and work. He has solid plans to engage the constituencies in the County. In particular, we were impressed by his passion for advocating to house our unhoused neighbors, including by providing wraparound services for mental and behavioral health.

# Whatcom County Prosecuting Attorney Endorsed: Eric Richey

- We encourage all Riveters to spend the time to read the written responses that the candidates submitted. Eric did an exemplary job of engaging critically with the questions we asked.
- Eric's experience in the office clearly translates into deep knowledge of the system and a demonstrable understanding of where change needs to happen.
- Though he hasn't necessarily been treated by the broader conversation as the "change candidate," we saw a passion in Richey for substantive, deep changes to the justice system.
- Richey has a notable head start in terms of his policy agenda because he can build on existing relationships and leverage them to implement best practices across issues.
- Richey was a vocal advocate for building measures for real transparency into the system. We were pleased to see his plans to "bring the prosecutor's office to the people."
- Richey supports many of the key pillars of the Riveters' platform.

passion to the interview and showed that he is an adept communicator. James showed
good alignment with key pillars of the Riveters platform, and we look forward to working

process and more just outcomes.

## WA State 40th District State Representative Endorsed: Alex Ramel and Debra Lekanoff

#### Alex Ramel
