## WHAT I DRAW

- **I am willing** to draw any genders, an original character(s), fanart, pairings/ships, kemonomimi, and soft NSFW & gore.
- I **won't** draw mecha, muscular people, elderly people, and heavy NSFW & gore.

## PAYMENTS

- All non-VGen payments must be processed via PayPal.
- All payments must be paid upfront.

## UPDATES & REVISIONS

- I will mostly update my progress during the sketch, lineart, and finishing phase. Please kindly ask if you need an extra update.
- Major revision (pose, composition, etc.) is only possible **twice** in both the sketch and lineart phase.
- I am willing to do a revision in the end if it is a minor change (slight color correction, liquifying a part of the artwork, etc.).

## DEADLINES AND DELIVERY

- You will be receiving a **digital file** only (PNG/JPG) via Google Drive or Email according to the request.
- The file will be delivered once the final product is complete. It should be finished in **2-4 weeks** unless I state otherwise.
- If I do not send the finished product in under a month without any explanation, a full refund will be issued.
- Refunds are **not** possible once the sketch is already being made, unless I decide otherwise.
- Rush delivery will be charged extra 50% of the final price. It will be stated as a rush if the artwork needs to be done within 10 days.

## RIGHTS AND USAGE

- **Personal Use:** The final artwork is for personal use only, such as printing for personal use, sharing on personal social media, or displaying it privately.
- **Commercial Use (Streaming/Content Use):** The final artwork is used as an asset in streaming or other content creation platforms. The commissioner may use the artwork as a stream's visual branding and promotional materials related to content. The artwork may not be used for profit.
- **Commercial Use (Merchandise/Ads/Prints):** The final artwork is used for profit. The commissioner may reproduce, distribute, and sell artwork on products, digital platforms, or in any other form intended to gain profits.

## INTELLECTUAL PROPERTY RIGHTS

- **Artist's Copyright:** The artist will retain full copyright and intellectual property rights to the artwork created unless a commercial license is purchased. Copyright includes the exclusive right to reproduce, distribute, display, and create derivative works based on the artwork.
- **Client's Rights:** Upon full payment for the commissioned artwork, the client is granted a license to use the artwork for personal, non-commercial purposes, such as displaying it online or printing it for private use. The client does not own the copyright to the artwork but holds a personal-use license that allows for the enjoyment and display of the art.
- **Rights for Commercial Use:** If the client wishes to use the artwork for commercial purposes (such as for selling prints, using it in marketing materials, or producing products with the artwork), a separate commercial license must be purchased. This license allows the client to use the artwork for specific commercial purposes outlined in the license agreement (e.g., product creation, merchandise, etc.). Without a commercial license, the client cannot legally use the artwork for commercial resale or profit.
