

Agreement and terms of use Dating App

This Agreement regulates the relations between the Administration of the information resource «Dating App» and an individual who seeks and disseminates information on this resource.

Information resource «Dating App» not a mass media, the Administration of a resource does not edit the information posted and is not responsible for its content.

A user posting information on the resource «Dating App», independently represents and protects its interests arising in connection with the placement of the specified information, in relations with third parties.

The following describes the rights and responsibilities of users and the administration, and describes the rules for user generated content.

1. About Dating App

1.1 Dating App is designed for your entertainment. We are not responsible for any decisions and actions that you take, based on what you worm and read on Dating App.

1.2 Dating App is not intended for trading, so any transactions that you take on yourself are your responsibility. You can not use Dating App to sell and buy any products or services.

1.3 Dating App developed and maintained for legitimate use only. You can not use Dating App to violate the law, violate the confidentiality, intellectual property of any person or organization.

2. Accounts on Dating App

To use the application, you must create an account that includes the user name (login), the real user name, email and password ("your account"). User while using the Dating App are prohibited:

User while using the Dating App are prohibited:

2.1 Register as a user on behalf of another person («false account») or to register a group (Association) of individuals or legal person as the User, it is possible to register in the name and on behalf of another natural person or legal entity subject to obtaining the necessary authority in the manner and form prescribed by the legislation of you country;

2.2 Confusing the users with your identity using the username and password of another the registered User;

2.3 distort information about yourself, your age or your relations with other persons or organizations;

2.4 Download, store, publish, distribute, make available or otherwise use any information that:

Hateful, threatening, defamatory, insulting, demeaning, honour and dignity, or business reputation, or violates the privacy of other Users or third parties;

Violates the rights of minors;

There are vulgar or obscene, contains foul language, pornographic images and texts or scenes of a sexual nature involving minors;

Contains scenes of violence or inhumane treatment of animals;
Contains a description of the means and methods of suicide, any instigation to commit;
Promotes and / or promote racial, religious, or ethnic hatred or enmity, fascism or the ideology of racial superiority;
Contains extremist materials;
Contains advertising or describes the appeal of narcotic substances, including "digital drugs" (audio files affecting the human brain through binaural beats), information on the distribution of drugs, their recipes and tips on usage;
Is fraudulent in nature;
2.5 Illegally download, store, publish, distribute, and provide access or otherwise use the intellectual property Users and third parties;
2.6 User is solely responsible for any information posted on the Dating App, according to other Users, as well as any interactions with other Users, at their own risk.
2.7 In case of disagreement with these Rules or their updates, the User must stop using it and inform the Administration of the Dating App in the prescribed manner.
Obligations of the User Dating App:

2.a comply with the provisions of the current legislation of you country, these Rules and other special documents of the Administration of the Dating App;
2.b provide accurate, complete and timely data, follow their actualization;
2.c inform the Customers about unauthorized access to the personal page and / or unauthorized access and / or use of the password and the login of the User;
2.d do not place on a personal page of information and objects (including links), which may violate the rights and interests of other persons;
2.e before placing the information and objects (including but not limited to images of other persons, strange texts of different contents, audio recordings and videos) to review the legality of their distribution;
Also there are mechanisms for:

You can block the accounts of other users of violators (spam, insults, pornography, copyright infringement, etc.)

You can tell us about the users-violators (spam, insults, pornography, copyright infringement and other)

3. Content on Dating App

Dating App gives users the right to self-generate content, thus:

3.1 You agree that you have the right to post everything that you post and that your user content does not infringe copyrights, trademarks, trade secrets or any other personal or property rights of any other party.

3.2 Administration does not bear any responsibility for the content provided by users.

3.3 Administration has the right to remove user-generated content without warning.

3.4 Administration moderates all user content and can delete user content if content violates resource rules.

3.5 You can flag objectionable content so that the administration can take action (delete the content if the content violates the resource rules)

3.6 Administration will take action against objectionable content reports within 24 hours, removing the content and ejecting user who provided the infringing content

4. Administration Dating App

4.1 Dating App administration provides technical possibility of its use by Users and is not involved in shaping the content of personal pages of the Users and does not control and is not responsible for the actions or omission of any person regarding use of the Dating App or the formation and use of the content of Users ' personal pages on the Dating App.
