Superintendent Report: Student enrollment – K-8 112, PreK 16, and Off Campus 4, for a total of 132. This is an increase of 1 from the September report. Mt. Vernon Overhead Door Company has been contacted regarding the bus barn overhead door openers. A quote for two openers amounted to \$2,200.00 (parts and labor). A worker came Friday to get started, but informed me he would have to do some carpentry work in order to install the openers. Parent/Teacher conferences were held October 24. The Mt. Vernon Conference was held October 25. The Washington County second property tax distribution was \$496,784.64, and the third distribution was \$157,872.76. Fire alarm testing was done last Friday. Our district's 2024 annual summative designation was commendable. This designation took into account items such as ELA/Math growth, ELA/Math proficiency, Science proficiency and chronic absenteeism. Discussion was held regarding Brain Games. As has been done in the past, our district will send at least

one team (7th and 8th graders) and two teams if there's enough interest shown. Our shooter drill was held October 18. Washington County Deputy Howard was on hand to help facilitate the drill. There were no student opt-outs. We also had a fire drill (with fire department participation) on October 11 and a bus drill on October 7. Discussion was held regarding weapon detectors. A newspaper article indicated that Centralia City Schools had approved the purchase of these detectors, and the board authorized Mr. Hodge to gather more information regarding these detectors. Discussion was held regarding the recent ROE13 Health Life Safety visit. As part of this visit, Clinton Electric was called to install a new circuit and GFI for the district washing machine and two new duplex receptacles to the existing circuit in the computer lab. Fourteen staff members elected to receive flu shots. Congratulations to Wade Zgonina! Wade recently competed in the Class S State Cross Country meet at DuQuoin State Fairgrounds. Wade placed 54th out of 132 runners. The basketball season has begun. Boys and girls are on the same team, and we have 21 players (9 girls; 12 boys). We play this week in the Tamaroa/St. Bruno tournament. The new basketball uniforms are in. As of this moment, I have no price. The basketball fund will contribute \$592.26. It has been respectfully requested that the board approve the purchase of new volleyball uniforms. The stipulations for these uniforms are that they be long sleeved and no short shorts. The volleyball fund will contribute \$847.12 toward the uniforms.
